Sir, I have the honour to inform you that would like draw your kind attention for the following facts.

That my daughter Athena pandit was mutilated from my home by force wherever I was posted in Shillong, BSF. HQ, Meghalaya. Sh. Nripendra Nath Sarkar, S/o Lt. Nikhil Ch. Sarkar, Sh. Palash Sarkar, S/o Nripendra Nath Sarkar and Sh. Pankaj Sarkar, S/o Nripendra Nath Sarkar of Vill: Gossainpur, P.O. + P.S. Bagdogra, Dist. Darjeeling, alongwith a group of arrogants showing arm creating terrors at night in my home.

That:- the aforementioned arrogants hypnotized and compelled my daughter to accept their proposals. They compelled herself for so-called marriage and influenced herself showing artificial sympathy.

That:- the aforementioned arrogant executed all dammas as pre planned by them.

Gradually they have been showing their actual intention demanding huge amount of money as dowry time to time.

They have been torturing my daughter both physically and mentally to fulfil their intentions.

That:- recently she has been beaten brutally by the arrogants for which my daughter fled away at my home town Alipurduar to save her life.

Now she has been suffering from severe both physical and psycho-phobiatcn problems due to inhuman and brutal torture by them.

Even the arrogants threatening my family members that they may commit murder any time at random.

The said culprits attacked my home at 12:10 PM yesterday night which has been investigated by the Officer In-charge by officer on duty.

My ailed daughter is under treatment and observation by the doctors and admitted under Shanti Mind Care, Siliguri, till resume normal condition.

Therefore, I request your kind honour to save life and property of my family members including my daughter under treatment and oblige.
