
Dear Sir,

I, Sri Badri Prasad Sharma, Son of Sri Chetraj Sharma, resident of Jaduvita, Milan More, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling beg to report you that on 27.08.2022 when I was about to board my flight for Chennai for my mother's treatment I received a call in my mobile phone. Talking in Hindi and introducing himself as an officer of Election Cell, Darjeeling D.M. office the caller had asked me if I am Badri Prasad Sharma, a teacher of Singimari Pry. School and also the B.L.O. of part 196? I admitted his question and replied him saying yes but regarding B.L.O. I said that of course I served as a B.L.O. for a few years but this time I am not holding any such post. In my reply the caller said "in computer record in our office (Election Cell) your name is still reflecting as a B.L.O. of part 196. May be the name of new B.L.Os. has not been sent from the Block but as per our record you are the B.L.O. and you have to be updated with our cell following some official instruction. As per the office record your Voter's I/Card is still not linked with your Addhar. Firstly, you have to open an App namely 'Any Desk' in your mobile and to link the same with your Aaddhar". Apart from this the caller had also told me that the payment of every D.L.A. henceforth shall be sent in different way. Being a teacher I had left with no alternate except to follow the instruction. So, I sincerely downloaded the 'Any Desk' App and thereafter inked the same with my Aaddhar. A little bit later I started getting massage of debiting the amount from my Bank Account and within a few minutes total sum of Rs. 69722/- was debited under the following manner:

I instantly informed the Bank and closed the account so the amount thereafter was stopped to be debited from my bank account.
