Subject: (CIR against Rahul Roy for Rash Driving)
Respected Sir,

I, Samir Kana, S/o Dil Bahadur resident of Rajiv Nagar New Darjeeling more, was travelling from Malbaguri to Darjeeling more, after having dinner around 23:40 hours on 10/09/22 along with my friend Furran Khan, S/o Rezwana Khan, resident of Rajiv Nagar, when at a very high speed a bike bearing registration Number WB 74 BH 0660 Crashed against my Scooty. I got injuries in my Pelvis and was admitted to Siliguri Hospital where I had to get multiple stitches on my Pelvis and my friend got hurt in his hand and legs. At the time of the accident we found that Rahul Roy and his friend were both drunk and in their intoxicated state they catch against our Scooty. The traffic police was on the spot and they took action against the rash rider. Rahul Roy and his family promised to pay all the damage provided we did not escalate the matter to whichever agreed on good faith since the culprit was quite young and we did not want to tarnish his image or humanitarian grounds. He told us not to call him and that he will provide compensation as much. My I-Phone Pro has been also damaged along with my Scooty.

I would kindly request you to look into this matter and take the most strict action against the accused.
