I "Bharti Paswan" W/o Pramod Paswan resident of Tikia Para, Pran Krishna Colony-2 Ward No. 28 S.M.C., Dist- Darjeeling Hindu by religion would like to report you the following facts:

- 1. That today i.e, on 12/09/2022 at about 1:45 p.m. one Nabin Mahato C/o Buddhu Mahato and his wife Bibha Mahato both resident of Tikia Para, Pran Krishna Colony-2 Ward No. 28 S.M.C., Dist- Darjeeling suddenly started abusing me in filthy languages for keeping sand infront of my house for the construction of my house. At that time I requested them to stop abusing me and told that the sand accumulated will be finished by the evening on construction of my house but they repeatedly told me to remove the sand at the very moment and then I told that is not possible to do so then they started assaulting me by fist and blows and said Nabin Mahato torn my wearing apparels and touched my body parts badly and Bibha Mahato caught my hair Log and dragged me on the road and in the meantime snatched away the neck chain made of silver and the silver ring made of silver from my neck and hand. Finding no other alternative I started raising hue and cry and my husband came to rescue me then they started assaulting him also and hit him on his head with spade and stone and blood started oozing out from his head and he fell down and seeing this I tried to rescue my husband from their hands at that time they with intention to murder me one of them Bibha Mahato caught hold my hands and Nabin Mahato tried to strangulate me out of strangulation I choked down and fell on the ground seeing this they out of fear they field away from there.
- 2. That thereafter local people took us to Siliguri Hospitai, there my husband was treated and he underwent three stitches and still on bed not able to follow his ordinary pursuing

I therefore request you to kindly take strict and appropriate measures against the above mentioned miscreants as such they couldn't create any more fear and problem for us. Shall be grateful for your act of kindness.
