My name is **Bonhi Dey** and I am a resident of Utpal Nagar, Daknikata, Ward No 46, Champasari, Darjeeling, WB-734003.

I am writing this letter in order to report an incident which took place on **25-07-2022**.

Respected, this incident happened at **NH 10 near Hotel Royal City (Capital O 75802)** in the **Evening (Time: 10:20 to 10:40 PM)** when my son was travelling to Champasari from his duty location city center mall. A person driving **Red or Maroon colour SUV type Vehicle** (registration number he didn't notice that time) **hit my son's bike from Side** & car driver didn't stop for helping purpose, he gone with car from that accident place, its completely **HIT & RUN Case**.
