In producing herewith one (01) accused person named Md. Anupam @ Aunpam (20), S/O-Lt. Md. Rafik of Vivekananda Road, Khalpara, W/No - 07, PS. Siliguri, Dist. Darjeeling. under arrest along with following seized articles;

i) One iron made improvised Fire Arms having its trigger, hammer and firing pin measuring approx 9.65 Inch including its butt, body and barrel loaded with one 8MM ammunition encrypted as "KF" on its percussions cap of the ammunition. Length of ammunition is approx 3 inch. [The articles have been found on the back side of his waist under cover of wearing apparel of accused Md. Anupam @ Aunpam & marked as 'Exhibit-A']

I, SI Basudeb Guha S/O Lt. Badal Chandra Guha of Siliguri PS, Siliguri Police Commissionerate would like to lodge this written complaint against the above noted arrested accused person to the effect that today on 15.09.2022 at about 20.45 hrs received a secret information that one person is in possession of firearms at Dangipara Railgate near Swastika Club, under Siliguri PS for committing heinous crime. He used to carry and possess small arms & ammunition with him. Wasting no time, I diarised the information in Siliguri PS General Diary Book vide GDE NO- 868 Dated 15.09.2022 and consequently informed the matter to I/C Siliguri. Subsequently, on being directed, I along with ASI Siben Sarkar, ASI Rabin Lama, ASI Debasish Das, ASI Subir Sen, CV/622 Ramanath Barman and CV/283 Prasenjit Dey left for Dangipara Railgate at 20.55 hrs for perusing the information by Govt. Vehicle. This refers to Siliguri PS GDE No- 869, Dated- 15.09.2022. Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

We reached at Dangipara Railgate near Swastika Club at 21.15 hrs and contacted two independent witnesses namely i) Tapan Saha(24yrs) S/o- Madan Saha of Jalpaimore, Natunpara, W/no-05, PS- Siliguri, Dist- Darjeeling and ii) Sachin Gupta(28yrs) S/o- Late Dinesh Gupta of S.P. Mukherjee Road, Khalpara, W/no- 09, PS- Siliguri, Dist-Darjeeling and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Subsequently, after contacting my reliable source and being informed, I along with my accompanied officer and force cordoned the area and could be able to apprehend one young boy. We searched him immediately and found one improvised small fire arms loaded with one live ammunition from back side of his waist under cover of his wearing apparel.

Subsequently, being interrogated, the apprehended accused person disclosed his identity as noted above. Further being interrogated he admitted that he has collected the said Fire Arms and ammunitions from Bihar. On demand he failed to produce any document in support of his possessing and carrying of such type of fire arms and ammunitions. Hence, it is evident that the accused named Md. Anupam @ Aunpam exclusively & consciously possessed this improvised fire arms loaded with live ammunitions illegally with some ill motives.

Thus, when his involvement in carrying and possessing illegal fire arms established, I seized and labelled the above noted articles at the spot under proper seizure list duly signed by him as well as by the above noted independent witnesses and also put my signature on the seizure list and label. I also arrested him preparing memo of arrest informing him ground of his arrest.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that the accused Md. Anupam @ Aunpam has carried the said fire arms loaded with live ammunitions with an objective to commit heinous crime in the locality.

So, I pray before you for starting a case against Md. Anupam @ Aunpam (20), S/O-Lt. Md. Rafik of Vivekananda Road, Khalpara, W/No - 07, PS. Siliguri, Dist. Darjeeling under proper section of law as he has wilfully violated the regulation of Arms Act and for arranging its investigation.
