On 12.09.2022 afternoon accompanied by Staff (2) Suranjit Sarkar (36) S/O Late Paran Chandra Sarkar designation lineman attached to Fulbarihat C.C.C WBSEDCL and S&LP Team of Jalpaiguri Region hold raid and inspection at Village: shalterbari, bhutki near bandhan bank PO. bhutki under P.S NJP. In course of inspection we had been to his premises of Krishna biswas (35) S/O Hriday biswas. He was present at the time of inspection. It is found that unauthorized extension of load and use in other purpose use of electricity. Connected load was 1. 6 nos fan 2. 3 nos Freeze 3. 10 nos LED bulb. 4. 4 nos 5. 1 nos water pump those material was seized since Seized properties are fragile in nature, may break or destroy at the time of packing and shifting them to your Police Station. Apprehending of the mischief I left all seized properties on Jimba to Hriday Biswas (36) of saltarbari, bhutki, under P.S NJP condition the same will be produced on call. Thereafter we left the premises. I prepare inspection Memo at 2.20 pm and disconnected electric connection and he has refused to put his sign at inspection copy.

Krishna biswas (35) S/O Hriday biswas a accused person who was committed theft of power of U/S 135(1)(e) Electricity Act. You are requested to take necessary action.
