Respected Sir,

I Pranab Mandal, s/o Sukumar Mandal, resident of Purba Phogdibari, P.O. Ghogomali, P.S.-Bhaktinagar, District: Jalpaiguri, beg to state as follows:-

1. That Namita Mondal is my sister who is married to Bikash Mandal s/o Subhash Mandal, resident of Subhashpally, Litchubagan, Ward No. 18 S.M.C., P.S. Siliguri, District Darjeeling from past 14years, and they have a son from the said wedlock.
2. That since the day of marriage the said Bikash, Mandal along with his father namely Subhash Mandal, Mother namely Shobha Mandal w/o Subhash Mandal and his two sisters namely Sandhiya Sarkar and Sapna Das started assaulting her and demanding for huge amount of money. On many occasions the said Bikash Mandal would send my sister to her maternal house and would ask her to get huge sum of money or else he would beat her and would not give her food and when she use to deny the same the said Bikash Mandal along with with his father namely Subhash Mandal, Mother namely Shobha Mandal w/o Subhash Mandal and his two sisters namely Sandhiya Sarkar and Sapna Das use to beat her with fists and blows and kicks and use to also drage her out of the house almost naked along with her child to get the money.

3. That on 12.09.2022 my sister was in her in laws house cooking food. Her husband suddenly entered the bedroom and started abusing her in filthy languages accusing her of all his miseries. When my sister objected his such accusation he became very furious and started to beat her with fists and blows and kicks. He pulled her out holding her hair locks and banged her against the gas stove threatening to burn her alive. Seeing this even her in laws came out and started supporting their son and got rods and battam to beat her up. The said Bikash Mandal along with his father Subhash Mandal and mother Shobha Mandal started to beat up my sister mercilessly and banged her body and face against the wall continuously and also threatened to kill her at the moment if she makes any noise or calls for help.

4. That on 14.09.2022 i.e. Wednesday at around 9:00 pm I got a call from my sister where on she said me that she is in a bad condition and needs emergency help. On reaching her home I found my sister in half conscious state whereon she was bleeding from different body parts and was unable to breathe and somehow got my sister admitted to the District Hospital at Court More whereon I learnt that my sister had been assaulted by the said Bikash Mandal, his father Subhash Mandal, mother Shobha Mandal and his sisters namely Sandhiya Sarkar and Sapna das brutally by iron rod, danda (stick), bamboo and other sharp objects bcz of which she received severe injuries.

5. That the said Bikash Mandal has caused innumerable teeth bites where her flesh has been totally exposed with blood oozing out of her back of my sisters body and has mercilessly beaten her up with rods whereon she has sustained grievous injuries on her private parts and the left side of her face has been swollen completely.

6. That it has been seen since long that the said Bikash Mandal has been continually assaulting my sister and demanding huge amount of money from her so that he can start new business and spend money for his personal benefits.
7. That my sister is still fighting for her life in the Siliguri District Hospital as her situation is very critical where at any moment anything may happen and she is also having a child who is of 11 years old and even he had been assaulted by the above mentioned persons.

I therefore request you to kindly take necessary legal actions the aforesaid culprits for the justice of my sister.
