Dear Sir,

I, Sri Barun Kumar Das, Son of Late Dwijendra Nath Das, resident of Gossainpur, Near Miloni Club, Post Office & Police Station - Bagdogra, Dist. Darjeeling in the State of West Bengal, do hereby beg to state as follows:

1. That I am a service man by occupation working with in a Health Department at Khoribari and permanently residing at the abovementioned resident since long time.
2. That in the year 2003 I had got married with one Nandita Maitra and after marriage I was leaving with my wife peacefully at the above mentioned residence. That due to our wedlock a male child was born, who is now 16 years old namely, Debanjan Das.
3. That on 28.07.2022 my wife Nandita Maitra lodged a false F.I.R. against me at Bagdogra Police Station and a specific case has been started against me being Bagdogra P.S. Case No. 365/2022 U/s. 498A/323/34 I.P.C.
4. That on the basis of the said case the ASI Ashish Karmakar of Bagdogra P.S. who is the I.O has not served any Notice U/s. 41 Cr.P.C. of the said case.
5. That thereafter I had filed a petition at Calcutta High Court Circuit Bench at Jalpaiguri being C.R.M.(A) No. 432 of 2022 and the Ld. High Court was pleased to pass an order directing the I.O. Bagdogra Police not to take any coercive step until further order and subsequently I have released on bail from the Hon'ble High Court.
6. That when I reached to Bagdogra P.S to comply the Order of Ld. Court I came to Know my Wife has also lodged a false complaint against me which was registered as Bagdogra P.S Case No. 397/2022 U/S 341/325/379/506 IPC .
7. That thereafter I have surrender before the Ld. ACJM at Siliguri and Ld. Court pleased to Grant bail in favour of me.
8. That by the said order of Calcutta High Court & Siliguri Court my wife Nandita Maitra along with his Boy Friend and some Local goons who are called themselves as a TMC Party worker they become furious and came to my house on

13.09.22 about 7.30 P.M and assaulted me and abuses me with filthy languages.

9. That on 13.09.22 at 7.30 P.M the said Nandita Maitra along with her boy Friend namely Niloy Ghosh (presently engaged with Ishwar Chandra Vidyasagar High School as a teacher) & her father namely Kamal Kanta Maitra and some antisocial goons came at my house with a motive of looting and killing me. They force fully open the main door of my house and tried to throw acid at my face and at the time of incident the Nandita Maitra (my wife) snatched my Gold chain and Rs. 5300/- (Rupees Five thousand Three Hundred) only from my wallet with the help of his Boy Friend with whom she is attached illicit relationship. Thereafter due to intervention of the local people they flew away from my house, but with a threatening to kill me and also threatened me that she have a Good Relationship with Local Party members and Media Person if the Local Police Station lodge any Complaint against them or her then they should face a consequences because she have a link with Upper Level Officer at Administrative Department.
10. That the Nandita Maitra is also doing service at Health Department and she is also a member in T.M.C. Party. That by using the power of political party, the said Nandita Maitra is doing such illegal activities and some political party member also unlawfully helping her to do so.

Under the above circumstances it is therefore request you to kindly take a necessary legal action against Nandita Maitra and her Boy Friend Namely Niloy Ghosh and her father namely Kamal Kanta Maitra and her associates for Theft, and assaulting and take necessary actions who are involved with her as per course of Law for the ends of Justice.
