I Sri Naren Singho S/o Lt Hari Mohan Singho R/o ~~Tanra~~ Kamargach Pa P.O Rangapuri P.S Phansidewa Dist: Darjeeling That today i.e. 16/09/2022 at around 6:30 p.m my son namely Subrato Singho S/o Naren Singho R/o Kamargach P.S Rangapuri Dist Darjeeling was going to Boowkali for some decoration works but while going to the said place when he was crossing Tarbandha which falls within the Jurisdiction of Bagdogra P.S at that time one person namely Hari Mohan Singho S/o Krishak Lal Singho along with his 5-6 friends ^{were} drinking Alcohol along side the said road and they have also covered the whole road my Above Named Son who was in his car and finding no way out and no place to move ahead he requested the said Above named person and his friends to move aside but they didn't did the same and in return started Abusing my son and when listening to all these my son resisted them and told them not to use such filthy words against him and family members they all became so furious ferocious that they

condition. So finding No way out I am lodging
this complaint that the said persons are given
proper punishment under law
