Respected Sir,

With due respect I, **RABINA KHATUN**, Wife of Md. Masudur Rashid, Residing at Suryasen Colony, Block - E, Ward No. 34 of S.M.C., Siliguri, P.O. Bhaktinagar, P.S. New Jalpaiguri, Dist. Jalpaiguri, would like to lodge this written complaint to the effect that I along with my husband **MD. MASUDUR RASHID** have been carrying on a Import & Export Business after obtaining a valid license from the authority in concerned, under the name and style as " M.R. Export & Import" and out of the income from the said business, we have been maintaining ourselves somehow.

Sir, yesterday i.e. on 13.09.2022 at about 11.00 A.M., my husband left the house carrying with cash amounting of Rs. 7,00,000/- only in order to deposit the same in the Bank Account of our said business, which my husband has collected and received against the Bill Voucher of the said business and also to collect certain business amount from one customer namely Md. Faruq.

While going towards the bank, my husband met with said Md. Faruq at Gate Bazar More, P.S.: N.J.P., Dist. Jalpaiguri, in order to collect a sum of Rs. 1,00,000/- only from him which is due and payable by him to my husband. During their conversation, suddenly, at that moment, some miscreants i.e. the members of Import & Export Association of Fulbari Border, namely (1) **Subhankar Naskar**, (2) **Md. Mustafa**, (3) **Sashi Mahammad**, (4) **Tapas Roy** and their engaged associates came to the spot with a four wheeler vehicle and forcefully abducted my husband and took him into the said vehicle and proceeded towards the Fulbari Border area.

Thereafter, at about 02.00 P.M., I got a phone call from my husband's number and after receiving the said phone call, I found said Sashi Mahammad is talking over phone and he informed me that they have kidnapped my husband forcefully and brought him in their Association at Fulbari Border and also threatened me by saying that if I want to see my husband alive, I have to present before them with a huge amount of money immediately.

Immediately after getting the said phone call, I went to their said Import & Export Association at Fulbari Border and after reaching there, I found that my husband was lying on the floor in almost unconscious condition and when I tried to rescue him, they restrained me and asked me to give money as per their demand and when I requested them with folded hands to release my husband, they became more furious and assaulted me physically inspite of knowing the fact that I have carrying pregnancy and also threatened me to leave the place immediately and also assured me that they will release my husband at night but till now, my husband did not return back to our house and I came to know about the entire incident from said Md. Faruq who is the eye witness of the said incident and presently, I apprehended that the aforesaid persons and their engaged miscreants might be murdered my husband and also evade all the evidences for their wrongful and illegal gain.

I, therefore, request you to investigate into the matter and recover my husband from the hands of the aforesaid miscreants and also take necessary legal action against them as per the provisions of law and obliged thereby.
