I Mr. Suresh Prasad S/O Bihari Prasad presently residing at Sisabasi, Milan More would like to submit a first information report regarding "hit and run" accident of my father Bihari Prasad ^{Page-67 yrs.} on 15th Sept 2022 at around 6pm at Sunny Mandir Main road on the way to Milan while returning from Champasari toward my home.

Sir My father was riding a ^{cycle} bicycle along with vegetable suddenly a two wheeler hit him ~~at~~ where he becomes unconscious, however the two wheller rider admitted my father at CHENNAI NURSING HOME, deridanga and leave his mobile NO:- 9304657900 at Nursing home. Then he flew away and did not return back nor answering phone calls any more. The condition of my father is pathetic and we are not in a position to continue his treatment without his support. Our financial condition is very poor and we start seeking help from societies for the life of my father.

Please kindly investigate the matter and support my father who is lying at bed of Hospital.
