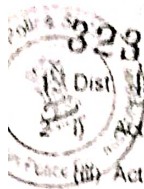

Sir,

In producing herewith three arrested accused persons named (1) Raja Das 24yrs s/o Biplab Das C/O Joydeb Das R/o Ektiasal bazzar near Nabjyoti Club Ward No 40 PS: Bhaktinagar Dist, Jalpaiguri along with seized articles (2) Raghu Paul @ Ashutosh 28 yrs, s/o Shyamal Paul R/o Saratchandra Pally near Polly Mangal Club Ward No 40 PS: Bhaktinagar Dist, Jalpaiguri (3) Raja Basfore 20yrs s/o Dinesh Basfore R/o Tikiapara Dompatti PS, Siliguri Dist, Darjeeling (4) Gulam Mustafa 36 yrs @ Kalua s/o Md Lal, Darbhanga Tola Ward No 6 PS, Siliguri Dist, Darjeeling (i) One knife measuring 12" including handle from the possession of Raja Das 24yrs which was kept concealed on the back side of his waist and one three cell torch light (ii) One sharp cutting weapon (Bhojali) measuring approx 15" including including handle from the possession of Raghu Paul 28 yrs @ Ashutosh which he was holding on his hand (iii) One iron rod measuring approx 23" one punch kept on his right hand recovered from the possession of Raja Basfore 20 yrs which he was holding on his right hand (iv) One hand made sharp cutting weapon (Dao) recovered from Gulam Mustafa 36 yrs @ Kalua which he was holding on his right hand under proper seizure list.

I, SI Uday Sankar Mandal of Panitanki TOP (Under Siliguri PS)/ SPC do here by lodge this written complaint to the effect that on 18.09.2022, at 00.10 hrs, I received secret source information that 7-8 persons had assembled back side of Surya Sen Park near Mahananda river area to commit Dacoity at that locality. Immediately informed the tip of information to O/C Panitanki TOP, and IC Siliguri PS, and noted the fact in GD vide Panitanki TOP GDE No 398 Date- 18.09.2022 and as per their kind instruction then and there, I along with ASI Ratan Kr Ghosh, C/576 Binoy Ch Roy, C/153 Santosh Mahato and CV/1007 Jiten Roy left for back side of Surya Sen Park near Mahananda river to verify the veracity of the information without any delay. At about 00.25 hrs, I along with police party reached at the spot i.e. back side of Surya Sen Park near Mahananda river area and parked our vehicle in a distant we proceeded towards back side of Surya Sen park on foot and being indicated by the source we found from the considerable distance that a gang approx of 7/8 persons were assembled behind the bushes at back side of Surya Sen park near Mahananda river and they were whispering in very low voice. Due to night, I search local persons for remain present during search and seizure as independent witness but none person shown nearby by the spot. Accordingly, we cordoned the place and approach towards them. But seeing the presence of police party, they scattered in multi direction and start to flee away to run from the spot but after a hot chase we manage to apprehended (04) three persons and others 4/5 persons were able to fled away from the spot. On interrogation, the apprehended persons disclosed their name & address as noted above, and started giving incoherent statement regarding their presence/gathering in the same place also. On further grilling they stated that, they along with 3/4 persons were assembled there in preparation to commit Dacoity at Dasarath Pally and adjacent area. Accordingly, I on being search in presence of the police witnesses the following deadly weapons was recovered i.e. (i) One knife measuring 12" including handle from the possession of Raja Das 24yrs which was kept concealed on the back side of his waist and one three cell torch light (ii) One sharp cutting weapon (Bhojali) measuring approx 15" including handle from the possession of Raghu Paul 28 yrs @ Ashutosh which he was holding on his hand (iii) One iron rod measuring approx 23" one punch kept on his right hand recovered from the possession of Raja Basfore 20 yrs which he was holding on his right hand (iv) One hand made sharp cutting weapon (Dao) which he was holding on his right hand. Accordingly, I seized the above noted recovered deadly weapons as under proper seizure list in presence of witnesses and duly signed by the accused as well as witness in between 00.35 hrs to 01.25 hrs, on being asked they failed to produce any satisfactory replied. Accordingly, I arrested them U/S 41 Cr.P.C issued memo of arrest and inform them their ground of arrest.

Under the above fact and circumstances, I pray before you that a specific case may kindly be started against (1) Raja Das 24yrs s/o Biplab Das C/O Joydeb Das R/o Ektiasal bazzar near Nabjyoti Club Ward No 40 PS: Bhaktinagar Dist, Jalpaiguri along with seized articles (2) Raghu Paul 28 yrs @ Ashutosh s/o Shyamal Paul R/o Saratchandra Pally near Polly Mangal Club Ward No 40 PS: Bhaktinagar Dist, Jalpaiguri (3) Raja Basfore 20yrs s/o Dinesh Basfore R/o Tikiapara Dompatti PS, Siliguri Dist, Darjeeling (4) Gulam Mustafa 36 yrs @ Kalua s/o Md Lal Darbhanga Tola Ward No 6 PS, Siliguri Dist, Darjeeling and 3/4 others under proper Section of law and arrange for its investigation.
