without food and they confine me in a room and restrict me to disclose the matter to any person and when I told my husband about the matter then my husband beated me mercilessly mostly everyday.

That in the month of March 2022 I conceive my pregnancy and by hearing this my inlaws family members is not happy and increase their torture rapidly day to day.

That on 26 -04-2022 during my pregnancy my husband on instigation of other above name in-laws family members when I was sleeping in my bed room at that time my husband came and suddenly kicked in my stomach forcefully and assault me by fist and blows and I fell down in floor and my husband threaten me by saying that "I will kill you and damage your pregnancy" and due to such assault I got severe pain in my stomach and I was treated by Doctor.

That my husband force me to bring 4 wheeler vehicle as a dowry from my parent and my said other in-laws family members demanded gold ornaments and cash as dowry otherwise they abort my pregnancy.

7. That several times during my pregnancy my husband assault me by blow by fist on my nose and I blood oozes out from my nose and I got very serious injury on my nose and

That at present I am 8 month pregnancy and I spend my life in very painful condition due to the heavy assault by above named in-laws family members and on 12-09-2022 I went to my in-laws house for staying there—but my husband and other family members restrain to enter into my in-laws house and drove out me from my in-laws house and I become helpless and unable to tolerate the painful days.
- 11. That my in-laws above named family members are liable for my painful days which I spent in my in-laws house and now my life is in very risk and I become helpless and due my health condition delay in lodging this complain.
- So, I therefore request you to kindly to investigate the matter and take necessary strict action against the above named persons and save my life from their
