Sir,

With due respect, I would like to lodge a written complaint against the 30/40 unknown persons of Sevoke Bazar Parijatnagar P.S Kurseong District Darjeeling.

In this regard, I beg to report that on 18.09.2022 at 14.55 hrs while performing K-37 Van Duty vide GDE No. 792 Dated 18.09.2022 and MCC No 1277/22 Dated 18.09.2022, I received an information from duty officer ASI Ramesh Bhirekothey and inform me that an accident had taken place at Salugara near Kendriya Vidyalaya School, NH 31, under Bhaktinagar PS, Dist: Jalpaiguri. Accordingly I shared the information with I/C BKN PS and as per his direction immediately myself along with force had been to P.O i.e Salugara, near Kendriya Vidyalaya School, NH 31. When I along with force reached to the spot and found that an accident had occurred between one scooty bearing No. WB 74BC5939 and one Govt. SNT Bus bearing registration No. SK01B0738. During enquiry it could be learnt that the due to rash and negligent of driver of Bus No SK01B0738 the scooty rider namely Sachin Chettri (35) died on the spot, Accordingly I arrested the Bus driver namely Birkhaman Gurung (37 Years) S/O Gokul Gurung of Lamaten PO + PS Rangli District Pakyong, Sikkim U/S 41 CrPC and taken into our custody and send him to Bhaktinagar PS through our Mobile Van. But when I tried to lift up the dead body of deceased Sachin Chettri at that time some 30/40 unknown persons of Sevoke Bazar Parijatnagar P.S Kurseong District Darjeeling area became very furious and restrained us to perform Govt Duty while taking the dead body of deceased Sachin Chettri but somehow I managed to lift up the dead body of deceased Sachin Chettri and forwarded his dead body to NBMC & Hospital for further process in the mean time the above noted alleged persons became very agitated and in the mean time some unknown persons serenely set fire on the offending Govt vehicle bearing No. SK01B0738 as a result the Govt offending vehicle burn totally but after arrival of fire brigade the fire personnel team doused the fire and alleged persons also blocked the National High way 31 for approx 1 ½ hours due to road blocked the national Highway disrupted traffic movement around 1 ½ hours. The alleged persons also threatened the police personal while performing govt duty. Further I along with force somehow could bring them under control and pacifying them. After informing duty officer, re-enforcement arrived at the spot and we could bring normalcy in the area. Later on I seized the burn offending Govt vehicle bearing No SK01B0738 in a fully burnt condition and I also seized the victim's scooty bearing No WB 74BC5939 in a fully damaged condition under proper seizure list u/s 102 Cr.P.C and brought to PS for further process. Over this incident one specific case has been started vide **Bhaktinagar PS Case No. 1013/22, Dated: 18.09.2022, U/S- 304 IPC** and endorsed to SI Ramanath Karjee for its investigation.

Under the above circumstance, I request you that a specific case u/s **186/435/427/506/34 IPC r/w sec 8 B of National High Way Act & 3/ 4 of PDPP Act** may kindly be started against 30/40 unknown persons of Sevoke Bazar Parijatnagar P.S Kurseong District Darjeeling and arrange for it's investigation of the case.
