In producing herewith one arrested accused person namely Mamik Barman (24yrs)@Ritu Barman, S/o Kalipada Barman of Adarshapally, Farabari, P.O- Sahudangi Hat, PS-NJP, Dist-Jalpaiguri along with the following seized articles as per proper seizure list -

1. 11(Eleven) sealed bottles of Tuborg Premium Beer containing 650 ml each.

I, ASI Uday Sankar Bhattacharjee of Ambari Falakata Out Post under NJP PS/SPC, lodged a written complainant against the above noted accused person to the effect that today on 18.09.2022 at about 13.05 hrs received source information that one person has gathered huge amount of liquor illegally and selling the same to the local customer at Sahudangi for his wrongful gain. This refers to Ambari Falakata out Post GDE No. 598, Dated 18.09.2022. Therefore, I conveyed the same to O/P, Ambari Falakata Out Post and as per his instruction I along with 1) C/- 230 Subash Das, 2) HG/1158 Hiten Roy, 3) VP-14 Paritosh Roy, 4) C/- Chandra Roy all of Ambari-Falakata O/P, Under NJP PS/SPC, proceed to Sahudangi. More to check out veracity of the information. At about 18.25 hrs we have reached at the spot and being identified by the source our police party held raid at Sahudangi, in presence of two independent witnesses namely 1) Abhinav Majumder S/o Lt. Ashim Majumder of Chakravita, PO, Kamarvita, PS-NJP Dist-Jalpaiguri and 2) Subash Sarkar S/o Lt. Narayan Sarkar of 09 No Colony, Ambari Falakata, PO, Kamarvita, PS-NJP Dist-Jalpaiguri and recovered (i) 11(Eleven) sealed bottles of Tuborg Premium Beer containing 650 ml each from the possession of accused person namely Mamik Barman (24yrs)@Ritu Barman, S/o Kalipada Barman of Adarshapally, Farabari, P.O- Sahudangi Hat, PS-NJP, Dist-Jalpaiguri. On being demand he could not produce any valid license documents in support of said liquor. He become nervous and admitted his guilt before us and stated that he sells the same to the local villagers since long for his wrongful gain. Accordingly, I have seized the above noted articles under proper seizure list in presence of above noted witnesses and took signature of the accused person and witnesses. The seizure was made in between 18.15 hrs to 19.00 hrs. Therefore, I have arrested the said accused under Cr.P.C. and issued Memo of arrest appraising the ground of arrest in presence of witnesses.

I therefore request you that a specific case may kindly be started against the said accused person namely Mamik Barman (24yrs)@Ritu Barman, S/o Kalipada Barman of Adarshapally, Farabari, P.O- Sahudangi Hat, PS-NJP, Dist-Jalpaiguri under proper section of law.
