Bhaktinagar , District Jalpaiguri Vide Plot No. 69(p), 77(p), Khatiyan No. 526/1, 526(3), J.L. No. 3, sheet No 11 which is Registered with mutation against my name . I had also constructed boundary pillars around my land.

On 20th March 2017 when I Visited the above mention land the accused person along with some land brokers has illegally and forcefully entered into the said land. Were trying to demolish my boundary demarcation and constructing a concrete house on my land

When I informed this matter to the New Jalpaiguri police Station, they immediately took action against Mr. Afas Ali and others and prevented them from that Construction . I had no other alternative way but to file F, I. R. against Afas Ali and Others

on dated 3rd October 2017.

I approached the local administration and police authorities several times who assured me that they were looking into the matter but as the time was passing away I got no relief.

On the contrary I gathered information on the first week of September, 2020 that they are representing themselves to be the owners of my said land and have circulated their desire to sell it and still now is Searching for prospective buyers. Now my prayers before you that the accused person should be ousted from my land. The main accused Afas All has entered into my land, illegally forcibly and in an unauthorized manner the Complainant is entitled to the restoration on the possession thereof after demolition of the

I hope you will pay adequate attention to the request and lodge this complaint hutment constructed by the accused person.
