Sir,

In producing herewith two female accused persons namely (1) Santi Sahani (32) W/O Ramdeb Sahani of Coolipara ,PS- Pradhannagar Dist- Darjeeling & (2) Ranjan Sahani (50) W/O Ananda Sahani of Coolipara ,PS- Pradhannagar, Dist- Darjeeling along with the following seized articles :-

1. 16(Sixteen) bottles of Russell's premium whisky each bottle containing 750 ml. blended & bolted by Mayell & Fraser Pvt. Ltd. Bageykhola, Majhitar, Rangpo, Sikkim, India.

I, SI Sibdhan Karmakar of Pradhannagar P.S under Siliguri Police Commissionerate do here by lodged a written complaint against 1) Santi Sahani (32) W/O Ramdeb Sahani of Coolipara ,PS- Pradhannagar Dist- Darjeeling & (2) Ranjan Sahani (50) W/O Ananda Sahani of Coolipara ,PS- Pradhannagar, Dist- Darjeeling ,to the effect that today on 20.09.22 at 08.15 hrs. Received a specific input from the source that the above noted lady persons has kept huge numbers of illicit liquor in their petty shop at Cooliepara, Siliguri Junction in order to sale the same to her design customers without any valid license for wrongful gain . Accordingly the fact is diarized vide Pradhannagar ,P.S. G.D.E. NO-1227 date 20.09.22, and informed the fact to you. As per your direction I along with CV/992 Jagadish Biswas ,CV/646 Baban Das , L/C-1274 Sushmita Mothey left for Cooliepara, Siliguri Junction under Pradhannagar PS to verify the veracity of the information. On reaching there and as identified by source cordoned the petty shop where she kept illegal alcohol. On arriving there found the above noted persons who disclosed their name & identity as noted above who kept the same at their shop in conceal position. On searching found 16(Sixteen ) bottles of Russell's premium whisky each bottle containing 750 ml. blended & bolted by Mayell & Fraser Pvt. Ltd. Bageykhola, Majhitar, Rangpo, Sikkim, India .On being interrogation they could not produce any valid documents/license or authority in respect of the said illicit liquor .They also stated that they are doing this liquor business since last few months for her wrongful gain. Accordingly, I seized the same in presence of witness as per proper seizer list duly signed by the witnesses. The seizure was made in between 08.45 hrs to 09.15 hrs. **All the seized liquor are Sikkim made liquor. Following which West Bengal Government revenue has been lost.** Apart from this local people are very much annoyed for selling the said illicit in said area . On being asked they stated that they kept the same with a view to sale and supply at Cooliepara area without any valid documents. As she has violated the rules and norms of Bengal Excise Act as such I arrested her with help of Lady constable keeping up decency and after observing all sorts 'of arrest rules for selling the said illicit without valid license.

Therefore, I pray before your Ld Court that a specific case may kindly be started against (1) Santi Sahani (32) W/O Ramdeb Sahani of Coolipara ,PS- Pradhannagar Dist- Darjeeling & (2) Ranjan Sahani (50) W/O Ananda Sahani of Coolipara ,PS- Pradhannagar Dist- Darjeeling as per proper section of law.
