Sub- Written complain against Susanta Das

Ma'am,

I, Smt. Lovely Das (Ghosh), W/o - Susanta Das, D/o- Laxman Ghosh, Resident of Deshbandhu Para, Pankaj Roy Sarani, Ward No 30, Under S.M.C, Dist- Darjeeling, PIN - 734004, do hereby inform you as follows:-


1. I lodge this complaint to the effect that on 06.11.2008 I got married to Sri Susanta Das, S/o- Late Ganesh Das, Resident of Deshbandhu Para, Siliguri. The said marriage was a love marriage and the marriage was solemnized in a temple situated at Shantinagar.
2. That soon after the marriage I came to know that he is a habitual drunker, and as such he was so into gambling that he used to spend a large number of his earnings on those activities. All this activities of him started affecting our matrimonial relationship
3. That upon inquiring of all his wrong activities he started abusing me both verbally and physically by beating me. After our marriage every time he used to beat me in drunken state instead every time I gave him possible chances to get back into mainstream as I always loved him.
4. Out of the lawful wedlock one Female child was born to us on 12.04.2014, Namely Ushashi Das. Soon after her birth my husband started pressurizing me by stating that he's not going to spend a single penny on me and my minor child as we were like a burden to him.
5. When our child was at the age of 04, my husband got engaged with another woman and after 06 months of their relationship I came to know about their extra marital relationship and I understood as to why he was least interested in maintaining me and my minor daughter.
6. That when all his extra marital things came to my knowledge he left me and my minor daughter just to stay with that women. Considering all these I lodge a complaint in Siliguri Women Police Station on 2017 against my husband and subsequently a case was initiated accordingly. My husband was too clever that he took advantage of my kindness and pretended like he has understood all his faults and he wants to get back into mainstream of his life, so again we started living together.
7. That from then he was doing pretty much fine but again after few months he started acting like previously how he was doing, he started over drinking and his behavior was so rough that the neighboring people were so frustrated from him. This time he showed his conservative mentality and again he started pressurizing me both mentally and physically. He restricted me from all my freedom, I wasn't allowed to talk to anyone not even my friends or customers or anyone who is male. And this time his tortures were not limited to me, he started torturing and abusing my minor daughter also. All his acts have been effected my daughter deeply. His tortures were beyond all the limits and hence it has become completely impossible for me to stay in the said flat. So I tried to take shelter in my paternal house but I didn't get any support this time from my parents. They didn't gave me any shelter and completely denied me of any shelter as my sister Smt. Jhum Choudhury was very much jealous of me because of that she pressurized my parents in a way and created a kind of burden upon them to restrict my entry in my aternal house and again by having no other option I came back to the said flat.

8. Then after for the well-being of me and my daughter, I sold all my gold ornaments and other precious belongings and collected some of 2,00,000/- rupees in order to open up a business to maintain me and my minor daughter. Roughly 03 months ago I've opened a Café near NTS More, Siliguri. Within a short time the shop started running good and was generating sufficient profit that was likely enough for me and my minor daughter. My husband noticed all these profits that caught his attraction just because of his greed for money again he started beating and torturing me. He used to snatch all my money, everyday soon after stepping into the house he used to demand the profit amount of the day and on refusal he used to forcefully snatch it all. His inhuman activities impacted my minor daughter badly.
9. That one month ago he forcefully broke into my café and threw me out of my café by saying that from this day this café belongs to me. He took the illegal possession of my shop and while protesting he tried to beat me in public place. Soon after that incident I have cancelled the trade license which was registered on my name but still till date without any valid trade license he's running the shop.
10. Just after the incidence my husband left us in our flat and went to his parents place where his mother lives that is in College Para, Siliguri, Darjeeling.
11. 9064232205 is the Contract Number of my husband. I tried calling my husband in his number multiple times and even texted him but I have been blocked from every way of communication. He is least bothered about me and my minor daughter, till date he haven't even tried to communicate with us. Me and my minor daughter is living a terrible life. I don't even have sufficient money to maintain ourselves for a long time as he took over my source of income.
12. Whenever my daughter is calling him from another number out of hunger and wants, he's sending very few things that is likely of giving nothing and also the waiting period is very long to get anything from him, because of all these reasons many days me and my daughter slept at night without having anything.
13. Nowadays he's started ignoring the calls of my daughter, whenever she calls her father for rations he use to cut the call or if he picks up then he uses filthy languages that he is not supposed use.

In the lights of the statements stated above, I would like to request the kind authority to kindly consider my request and look into the matter in a very serious manner. Your kindness will be highly solicited.
