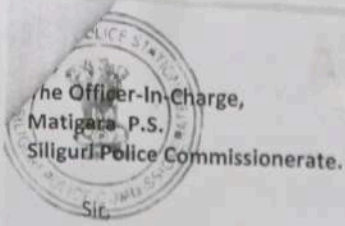

With due respect, I am producing herewith 03 (three) arrested accused persons namely (i) Dilip Sao (40 yrs) S/O Late Nandalal Sao of VIII- Vivekananda Pally, PO- Kadamtala, PS- Matigara, Dist.- Darjeeling (ii) Roshan Ali (24 yrs) S/O Kudrus Mahammad of Sutki Godwn, PS- Matigara, Dist.- Darjeeling and (iii) Sunil Mali (19 Yrs) S/O Mahesh Mali of Biswas Colony, Matigara, PS- Matigara, Dist.- Darjeeling and the following articles under seizure :-

1. One iron made sharp cutting weapon called as Bhojall recovered from the possession of accused Dilip Sao S/O Late Nandalal Sao of VIII- Vivekananda Pally, PO- Kadamtala, PS- Matigara, Dist.- Darjeeling.
2. One steel made sharp cutting knife and one torch light recovered from the possession of accused Roshan Ali S/O Kudrus Mahammad of Sutki Godwn, PS- Matigara, Dist.- Darjeeling.
3. One steel made sharp cutting knife recovered from the possession of accused Sunil Mali S/O Mahesh Mali of Biswas Colony, Matigara, PS- Matigara, Dist.- Darjeeling

I, SI Goutam Mallik of Matigara PS, Silliguri Police Commissionerate beg to state that on 21.09.22 at 01.35 hrs received a reliable secret source information that that a gang of miscreants assembled at below Chamta river bridge, Chandmoni under PS- Matigara, Dist.- Darjeeling with deadly weapons and making preparation for committing dacoity at Pati colony area. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 1223 dated 21.09.22 and informed the fact the Officer-In-Charge, Matigara PS, SPC and as per his kind order and direction I along with ASI Dharendra Nath Mandal, ASI Tapan Das, C/ 974 Mintu Sen, C/1053 Paresh Rava, C/219 Sanatan Chitrakar, C/374 Debraj Biswas, CV-155 Sukumar Das and CV- 387 Sukumar Barman all of Matigara PS, SPC left for Chandmoni under PS- Matigara, Dist.- Darjeeling to verify the veracity of said source input. I also informed the fact to Night RT Van officer PSI Sailesh Subba of Matigara PS and directed him come to Chandmoni to accompany with us. At 01.55 hrs we arrived at Chandmoni near Chamta river bridge under PS- Matigara, Dist.- Darjeeling. After a few time RT Van Officer PSI Sailesh Subba along with force came at Chandmoni and accompany with us. At about 02.10 hrs as indicated by the source we noticed that 07/08 persons assembled below Chamta river bridge and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 03 (three) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in the middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity in a house at Pati Colony area. On search the above noted weapon of offence recovered from their possession. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested above noted 03 (three) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to Matigara PS. The search seizure and arrest made on 21.09.22 in between 02.50 hrs and 03.45 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted arrested 03 (three) arrested accused persons namely (i) Dilip Sao (40 yrs) S/O Late Nandalal Sao of VIII- Vivekananda Pally, PO- Kadamtala, PS- Matigara, Dist.- Darjeeling (ii) Roshan Ali (24 yrs) S/O Kudrus Mahammad of Sutki Godwn, PS- Matigara, Dist.- Darjeeling and (iii) Sunil Mali (19 Yrs) S/O Mahesh Mali of Biswas Colony, Matigara, PS- Matigara, Dist.- Darjeeling and others and arrange for its investigation.
