


With due respect, I beg to report that I, SI Sajal Roy of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge a written complaint against the owner of "Tinkers Bar" and others which is situated at Sevoke Road, PC Mittal Compound under Bhaktinagar PS, Dist: Jalpaiguri to the effect that today ie. on 21.09.2022 I along with SI S. Chaterjee, SI Chiranjit Saha, CVF Biplab Roy of Bhaktinagar PS as per order of IC Bhaktinagar PS, SPC had been to Tinkers Bar for enquired about the incident which happened on 10.09.22 evening. During enquiry locally and after seeing the CCTV Footage of Tinkers Bar and found that maximum days this bar was open after fixed time and also customer and lady singer are dancing inside and outside Bar in public place by using the full sound of music and they are showing obscene act, public nuisance and indecency inside the Bar and outside the Bar as result local people are annoyed with the owner of the Bar resulting annoyance of local public due to their act there are likely to beach of peace or disturb the public tranquility at that area. As per govt. rule and regulation the permissible time of singing performance inside the Bar is 23.30 hrs, the owner of "Tinkers Bar" violated the rule of 239 of West Bengal Excise (Foreign Liquor) Rules 1998. Previously several time instructed to the owner of said bar to stop the dance performance and close the Bar timely but the owner/manager of said Bar did not pay any heed.

I, therefore, pray before you that a specific case may kindly be started against the owner of "Tinkers Bar" and others and arrange for its investigation.
