I MONIKA LAKHOTIA, Wife of Manish Lakhotia, Daughter of Sri B.L Karnani, Hindu by faith, Presently residing at Ashtha Apartment, Champasari, Opposite Aman Medical, Naya Basti, Siliguri P.O. & P.S. Pradhan Nagar, District - Darjeeling - 734003 would like to draw your kind attention in the matter as follows:-

That I am married to Manish Lakhotia S/o Sri Raj Kumar Lakhoti. Our marriage was 1. solemnized on 19th January, 2004 at Maheshwari Bhawan, Agresen Road, Siliguri and We have two daughters from the said marriage namely Yashvi Lakhotia and Urvi Lakhotia.

- That in the year 2021 due to some matrimonial conflict between me and my I along with my children started residing with my family at my matrimonial house at Champasari Siliguri in order to solve the conflict and mend ways however in the month of September 2021, it came to my knowledge that my husband had been charged in a case and since then he has been absconding.
- That since the time my husband has been away, the behavior of my in-laws have 3. completely changed towards me and my children.
- That my in-laws namely Raj Kumar Lakhotia, Sumitra Lakhotia, Sunil Lakhotia, Pooja 4. Lakhotia and Varun Lakhotia have started mistreating me and my minor children.
- That I was running a shop of kids garments and toys by the name of "R U Kidding" at 5. Planet Mall, Siliguri and by the earning from the shop I used to incur our expenses but due to the constant threatening and pressure by my in-laws, I was forced to close down the shop. However my in-laws assured me that they would help me to meet my finance.
- That during the initial month I was provided with a minimum amount with the help of 6. which I would meet my and my children's personal expenses but since last six months I

- 7. That my children and I are being deprived of our basic necessity. Often the vegetable fruits milk which are brought are kept away from us and My children are often ignored and looked down upon in comparison to the other members of the family. They are continuously forcing me leave the house and move out with my children.
- 8. That whenever I feel sick, no one come forward to take me to the doctor or bring me medicine. Once when I had a severe stomach ache, no family members provided me with any medicine or help and ultimately I was forced to seek help from my parents. The situation became worse when my children weren't taking care of.
- 9. That since past few weeks my in-laws have started to humiliate me and defame me. Time and again they make calls to my relatives and friends and speak ill about me. I am not given any space or freedom to do anything in the house
- 10. That I am often left at the mercy of my parents for meeting my daily expenses. With each passing days it has become very difficult for me to deal with the situation but owing to the values given by my parents, I have always made every effort to deal with the miserable situation and keep quiet for the peace of mind but the behavior of the in-laws and the absence of the husband have just added to the misery.
- 11. That currently I am looking after a PG situated at Khalpara with the help of a family friend. Before commencing the business my in-laws promised me and our family friend that they will invest in the PG and they will provide financial aid but with the passing time they neither provided any financial aid nor showed interest to do so. Their breach of promise is now depriving me to flourish my business.
- 12. That now the situation has become intolerable and my mental state has degraded. I am in a state of true perfidy with merely no source of income and two daughters. In 18 years of this marriage, I had selflessly given in this relationship emotionally, physically, mentally and demanded nothing but self-respect, support and love which I was deprived off and now I am in the state of helplessness and all my endurance have failed.

Therefore you are humbly requested to look after the matter and take strict action against the aforesaid culprits and initiate a criminal case against them under section 498A and other sections as you may deem fit and proper.
