Regarding Domestic Violence, Threats, Suicide and Homicide

Dear Sir,

I am writing in regard to a situation where I have been married to my husband Biju Kurian since 2006. Ours was a love marriage but over the years has been violent and finally in 2021, I asked that we separate. Because of this, last year he threatened to do many things to me, put me in prison, put my family in prison, and even commit suicide. Three times, he has mentioned taking the lives of the children and himself too. I have two sons, 15 and 10 years old.

He has hacked into my Facebook and WhatsApp before impersonating me and recently went to Twitter, Facebook and shared defamatory things about my character. Now he says he wants to destroy me, my work and my reputation so that I will never work again.

As a form of protection, before he harms me, the children, even himself or others, I am lodging a complaint because he refuses to take psychiatric help. He fights with the neighbors and my mother had to leave her own house because he was terrorizing her.

During our marriage if I said anything that irked him, he would take revenge on me for days and I would get petrified. He did not allow me to have my own friends, I was isolated. As I am a writer and also a social worker, he mocks my writing, poetry, and my social work and he wants to destroy that.

Over the years, he has used my bank account, my entire salary went to him, he hid the password from me telling me I did not know how to use money. Even though he used my entire salary for the house plus his, every month, before the end, we were broke and I had to keep asking for money from my family, friends or relatives. I was embarrassed.

He rarely would carry his phone before and if I asked him why he was late when he went out, he would explode calling me names such as churail, bitch, kutiya, nowadays, he calls

me filthy names day and night and my children are terrified. It is so bad I had to speak to the school Dean about our problems.

Earlier, he hit me on head, recently bit me many times in anger, hit me on face, smashed my eye, threw me across a room and one day, when I was pregnant with my first child, kicked me on leg, my leg got infected and I got cellulitis. I was admitted to a hospital and a portion of my leg had to be cut off, and I told everyone I fell down, this was in Bengaluru.

Over the years he has rammed my head, kicked me, slapped me and called me countless names, dumb and brainless woman. I used to cry and pray to God every day to change things. He would get a little better and then again, a new issue would rise.

When we came to Siliguri, he suddenly started to hate my mother, whose house we were living in. He started behaving with her very badly. One day, when he was acting violently, she tried to take a picture of that and he threw hot tea of her, she is above 80 years old and dragged her out of her own house. He has fought with her too when she tried to tell him to stop behaving badly with the neighborhood because all the building people have seen this, he was angry with them too.

In Hosur, TN, when he hit me very badly in 2014, that was the first time I told him I would go to the cops. He took my 2 year old son with him and threatened to kill him and himself. Frightened, I reached out to the president of the colony we were living in who managed to speak to him.

When we didn't have money, he made me sell my wedding chains and rings.

I took anti-depressants for a year, and he started to call me psychotic woman, mental woman and tells lies about me to others, all the time.

He smashed my mother's mobile, her treasure cupboard, and many other things. He hacked into WhatsApp and started sending derogatory messages around about her, he terrorized her so much that she left her own house, left Siliguri, and changed her number. My mother was a highly respected school teacher and was very kind to him.

I am finally taking police action. I have told him to take treatment, to get better. He pretends he will. He told me to give him time to leave the house, he needs money to leave, but I know he will not leave, and even if he will, he will not stop stalking me to harm me and next he may harm my mother and sisters, as he has threatened to do before. I have informed his brother about the situation, who lives in Chattisgarh.

Right now, I don't want him around me or children and stop his cybercrime activities with intent to destroy. I am terrified to sleep at night, hide my phone and switch it off all

the time because he takes it and hacks in, and has even changed my passwords. He has broken all the latches in the house including the front door, we don't have a latch of protection.

I have told him if he hates me so much, lets go for separation or divorce, he is not willing to let me go, nor go and does not want me to live and work either. He just wants to destroy me,

He did the same thing to his own sister, there was a family issue and he went to social media and spread all stories about her and put pictures of her. Finally, he spoiled her reputation and she lost her very good job. He was very happy about it. All his cousins and sister do not speak to him because of this behavior. When her husband had brain cancer, he messaged him very good you got it.

This is the person I am dealing with. For a long time, everyone is telling me to go to the police, I was thinking to give him time, but he is only getting worse.

He will never stop haunting me unless people take action because he is very clever, he knows how to lie and trick people. He is two people inside and people who don't know him well will never believe it because he speaks very gently and can be very helpful too.
