I, SI Sibdhan Karmakar of Pradhannagar P.S, SPC would like to lodge this written complaint against the above noted accused persons and others to the effect that on 23.09.22 at 00.15 hrs I received a source information that 14/15 persons were assembled at Bani mandir Play Ground near gate bazar under Pradhan nagar P.S. area with deadly weapons with a view to commit some heinous crime. Accordingly, I inform to you and diarized the matter vide PDN PS GDE No. 1406 dtd.23.09.22 and as per your kind instruction myself along with C/762 Mojibar Rahaman, CV/223 Swapan Chhetri, CV/128 Ajay Kr Sahani ,

CV/242 Rakesh Mangar, CV/646 Baban Ch Das, CV/992 Jagadish Biswas, CV/645 Pankaj Gupta, took departure for the spot . We reached near the spot as confirmed by the source and stopped at a considerable distance from above noted spot and we started walking towards the P.O with due care so that no one could anticipate our movement. At about 00.55 hrs we reached at Gate bazar near Bani mandir Play Ground under Pradhan nagar P.S and found a group of 14/15 persons assembled and gossiping there. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately, one of the people among the gang saw us and shouted "Police" at the top of his voice. Thereafter all of them started fleeing in multiple directions. Somehow, after a hot chase we could able to apprehend the above noted 10(Ten) persons.

On interrogation they disclosed their identity noted above and also stated that they along with other associates with them had assembled there with a view to commit dacoity after making full preparation at Gate bazar Area . Thereafter all the apprehended persons were searched and due to late night, I could not find any independent witness to be present at the time of search and seizure. During search the above noted articles were seized from their possession.

All the articles were seized on 23.09.22 between 01.35 hrs to 02.45 hrs issuing a proper seizure list duly signed by the accused persons. Thereafter all the persons were arrested with proper memo of arrest, and accordingly myself along with force with arrested accused persons returned back at Pradhan nagar P.S.

Under the above circumstances, I pray before you that a specific case may kindly be started against the arrested accused persons namely (1) Hassan Raja @ Subrata (28) S/O Allauddin Md of Mallaguri ,Ratanlal Busty ,P.S-Pradhannagar,Dist.Darjeeling(2)Akash Tamang (27) S/O Palden Tamang of Tong Song ,Chowrasta ,P.S-Sadar,Dist.Darjeeling,(3) Arjun Chettri (25) S/O Nar bahadur Chhetri of Tanak Busty 4th mile ,P.S & Dist.
