Sir,

With due respect and in producing herewith the arrested accused namely Narayan Barman (32 yrs) S/O Bisadu Barman of Rana Nagar, PS- Matigara, Dist.- Darjeeling (Driver of vehicle No WB/39/0308) along with following seized articles under proper seizure list :-

- 1) One vehicle (Shaktiman Truck) bearing Reg. No. WB/39/0308 loaded with illegal River bed materials.

I, SI Uday Chakraborty of Matigara P.S, SPC do hereby lodge this Complaint against the above noted arrested accused namely Narayan Barman (32 yrs) S/O Bisadu Barman of Rana Nagar, PS- Matigara, Dist.- Darjeeling to the effect that on 22.09.22 at 19.45 hrs I received a specific source information that one truck (Shaktiman) bearing Reg. No. WB/39/0308 loaded with illegal River bed materials is coming from Balasan river Bed, Bhairaber Ghat, Rana Nagar under PS Matigara, Dist.- Darjeeling without any valid documents. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 1334 dated 22.09.22 and informed the fact to the Officer-In-Charge, Matigara PS and as per his kind order and direction myself along with force had been to Rana Nagar under PS Matigara, Dist. Darjeeling. After arrival at near Basanti Pujar Math, Rana Nagar we noticed that one Shaktiman Truck is coming from Balason river. Accordingly we detained the said truck displaying number plate WB/39/0308 loaded with illegal River bed materials at near Basanti Pujar Math, Rana Nagar under PS- Matigara, Dist.- Darjeeling and also noticed only the driver inside the cabin of the said truck. On being asked he disclosed his name and identity as noted above. On demand he failed to produce any documents in respect of illegal river bed materials loaded in his vehicle. On further interrogation he disclosed that he mines such river bed materials from Balason river near Rana Busty by illegal means with a view to sell the same for his illegal gain. Accordingly, I seized the above noted vehicle having registration number WB/39/0308 loaded with illegally mining river bed materials under proper seizure list and arrested him after maintaining all formalities of arrest and brought to Matigara PS. The search and seizure was made on 22.09.22 in between 20.25 hrs and 21.15 hrs.

Under the above noted fact and circumstances, I therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused namely Narayan Barman (32 yrs) S/O Bisadu Barman of Rana Nagar, PS- Matigara, Dist.- Darjeeling and arrange for its investigation.
