I, Shabnam Parveen, W/o MD. Guddu resident of Vivekananda Nagar, Koyla Depo, Ward No. 7 of SMC PS & PO Siliguri, Dist Darjeeling beg to respectfully inform you that I am a Housewife women. My husband doing job in another state. My mother-in-law and me only two women live at home. Today on dated 19/09/2022 almost 1:30' o clock in afternoon when my mother-in-law was not present at home in that time my neighbours whose name Md. Wasim S/o Md. Shamsul came to my house during the day then I thought that he has come for some work. But after entered my house he suddenly closed the door. When I came in front of the door and ask him what happen, why you are closed the door, then he say me that he need some money amount Rs 1,00,000 (1 lac) in credit. After somedays he pay all the amount. I refused it and told him open the door and try to open the door that time he grave me in a dirty way and touch on my chest, I got scared and started shouting then he started slap me he grabbed my hair and dropped me and started running away. After opening the door my brother Sahnawaz(Chottu) who is coming my home hearing my sound he caught him on road. He also beat my brother due to which he has got hurt in chest. He tried to kill him from a rod which is kept on near by. When my other neighbours come in this incident he blame me on the contrary. In this incident my cloth were also torn. Now he threatening me that if I go to the police or councilor office then he will harm my family me and my mother-in-law. We are two women and my husband is not present at my home. I am afraid that something is wrong work don't by Md Wasim .

So I requested to you that please takes some strict action against them. I am highly obelighed with you.
