Das Road Millanpally have spent my staff Vijay Razak to
Punjab National Bank to deposit 45,000/- on 22-9-22 at 11:20 am
at S.F. road. But in the bank he met with two boys.
They told him that they wanted to deposit 2 lakh in their
account but they don't know how to fill the form. One boy
told to my staff that you deposit the 2 lakh money and
give me your money as he was in rush to catch the bus to Bihari
and there were no link on the bank. So he give 28,000 in three
times 1st - 10,000, 2nd - 10,000, 3rd - 8000 in total - 28000/- and
the 1st boy left the place and the 2nd boy told him to go the
bank and he will be coming in a min so my staff taken the
2 lakh rupee note bundle and was going to bank then he
saw that the 2nd boy was not there and the note bundle
which he have was only paper no money were there. He
meet the 2 boy on Punjab national bank their photo should
be come in their CCTV camera. and the rest 17,000 was
deposit in the my bank account. This incident took place
between 11:30^{am} to 12:30 pm.

So, I request you to kindly solve this case as soon as possible
