In producing herewith arrested 06 (Six) accused persons namely (i) Nandu Tirkey (24yrs) S/o- Sahorey Tirkey of Chittaranjan Colony, Bagrakote, W/no- 20, PS- Siliguri, Dist- Darjeeling, (ii) Punit Paswan (24yrs) S/o- Rajkumar Paswan of Tikiapara Matangini- II, w/no- 28, PS- Siliguri, Dist- Darjeeling, (iii) Sujit Lama @ Tapa (28yrs) S/o- Lt. Sankar Lama of Baribasa, Madani Bazar, PS- NJP, Dist- Jalpaiguri, (iv) Dipak Das @ Nepu (26yrs) S/o- Lt. Dilip Das of Durgadas Colony, W/no- 20, PS- Siliguri, Dist- Darjeeling (v) Rabi Gupta @ Tiki (19yrs) S/o- Satyanarayan Prasad Gupta of Bhangapool, Palpara, PS- Matigara, Dist- Darjeeling, (vi) Subir Sarkar @ Bocha (52 yrs) S/O- Lt Anil Chandra Sarkar of North Bharat nagar W/No- 23 PS- Siliguri, Dist- Darjeeling, arrested u/s- 41 Cr.P.C along with following seized articles viz:

1. One iron made sword measuring 32 inch (approx) including butt from the possession of Nandu Tirkey which was kept concealed on his back side,
2. One iron made rod measuring 29 inch (approx) including wooden butt from the possession of Punit Paswas which was kept on right hand,
3. One iron made crowbar measuring 20 inch (approx) including wooden butt from the possession of Sujit Lama which was kept on his right hand,
4. One iron made 'Knife' measuring 11 inch (approx) from the possession of Dipak Das which was kept on his back side,
5. One iron made 'Kukri' measuring 18 inch (approx) from the possession of Rabi Gupta which was kept on his right hand,
6. One iron made 'sword' measuring 28 inch (approx) from the possession of Subir Sarkar which was kept on his right hand.

I, ASI Debasish Das S/o- Haripada Das of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Nandu Tirkey, (ii) Punit Paswas, (iii) Sujit Lama, (iv) Dipak Das (v) Rabi Gupta, (vi) Subir Sarkar and others to the effect that today on 23.09.2022 at 00.45 hrs received a sources information that 12/13 persons have assembled at Backside of Tarai School Ground, Deshbandhupara under Siliguri PS with a view to commit docoity in a house at Deshbandhupara area. The fact was diarized in GD vide Siliguri PS GDE No- 1306 dated 23.09.2022. Subsequently, after sharing the information with I/C Siliguri PS and as per his direction, I along with ASI Siben Sarkar, ASI- Subir Sen, C/260 Sukunđu Roy, C/1192 Nepal Barman, CV/283 Prasenjit Dey, CV/622 Ramanath Barman left for the place to work out the information. At about 00.55 hrs after reaching near Tarai School Ground, Deshbandhupara under PS- Siliguri I met my source and being pointed by the source we started walking towards back of Tarai School Ground. At 01.15 hrs reaching back side of Tarai School Ground started cordoning of the suspected persons as shown by

the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted Six (06) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoit in a house at Deshbandhupara area.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.35 hrs to 02.15 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Deshbandhupara area. It is also revealed from them that Poltu, Promod, Totan, Rabi and others have assembled there with them and planned for committing the dacoit.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Nandu Turkey (24yrs) S/o- Sahorey Turkey of Chittaranjan Colony, Bagrakote, W/no- 20, PS- Siliguri, Dist- Darjeeling, (ii) Punit Paswan (24yrs) S/o- Rajkumar Paswan of Tikiapara Matangini- II, w/no- 28, PS- Siliguri, Dist- Darjeling, (iii) Sujit Lama @ Tapa (28yrs) S/o- Lt. Sankar Lama of Baribasa, Madani Bazar, PS- NJP, Dist- Jalpaiguri, (iv) Dipak Das (26yrs) S/o- Lt. Dilip Das @ Nepo of Durgadas Colony, W/no- 20, PS- Siliguri, Dist- Darjeeling, (vi) Subir Sarkar @ Bocha (52 yrs) S/O- Lt Anil Chandra Sarkar of north bhorot nagar W/No- 23 PS- Siliguri, Dist- Darjeling, and others and arrange for its investigation.
