Respected Sir/Madam,

That I, Santosh Devi Rathi, Wife of Sri Bhanwarlal Rathi, is a permanent resident of Dr. Kalinath Road, Nayabazar, P.O Siliguri Bazaar, P.S Siliguri, District- Darjeeling, Pin Code: 734005. That since 1966, I along with my husband have been residing at our abovementioned residence with my husband. That for the last few months my nephew Sri Pawan Rathi, Son of Sri Dhanpath Ray Rathi, who is also a co-resident of the said abovementioned residential premises have been illegally and unlawfully trying to oust me and my husband from our said residential accommodation. That yesterday at around 12:00 P.M. the said Sri Pawan Rathi atrociously and mercilessly had physically assaulted me and have also torn my apparels and tried to choke me to death and that somehow with interference of other relatives I was rescued from the assault of the said Sri Pawan Rathi. That thereafter Pawan Rathi entered into my bedroom and started to throw off my belongings, and threatened me with life if I did not vacate my said residential premises immediately. That both, my husband and myself are old aged people who stay all alone in our abovementioned residential premises. That after today's threatening act by the said Pawan Rathi both my and my husband are under extreme mental trauma and depression.

Hence, I request before your goodself to kindly look into the abovementioned matter and take necessary legal action against the said Pawan Rathi as per the due course of law for the ends of justice.
