Subject : FIR AGAINST MY HUSBAND SUMIT SARKAR.

Sir,

I, Sudhrita Paul got married to my husband Sumit Sarkar (s/o Swapan Sarkar, resident of Vidyasagar Road, Khalpara, Siliguri) on 19th January 2006 as per customs and traditions of Hindu marriage. After that, I gave birth to two sons - My elder son Supriyo Sarkar was born on 1st December 2006 and younger son Suneet Sarkar was born on 9th July 2014.

Right after my marriage, mental and physical torture started by my husband and his family members. They used to verbally abuse me on a regular basis on any excuse, especially my mother-in-law Mithu Sarkar. Mithu Sarkar also extended the abuse on me physically by her son. She used to instigate her son to physically torture me. On a daily basis her son Sumit Sarkar used to come home late at night in drunken condition. On protesting against these actions of his, I was beaten by him on many occasions.

Not only that, he was given a gold chain and a gold wrist bracelet during the aashirvad ceremony. Alongwith that he also sold some jewellery of mine, my elder son Supriyo's necklace which was a gift to him during his rice ceremony (annaprashan). I tolerated all types of torture meted out to me just for the sake of my two sons. Day after day this verbal/mental/physical abuse continued. He used to come home in drunken condition late at night and beat me up in front of my elder son. This became a regular feature.

Not being able to take it anymore both mentally and physically, I came to my parent's house on August 2012. It was only then, I told my father and mother about my sufferings during my stay in my in-laws family. When my father called them up on phone, he was assured by Mithu Sarkar that she would herself improve on her behaviour and approach as well as she would tell her son to mend his ways. They also requested my father to let him stay at our ground floor apartment till the time she (Mithu Sarkar) buys a small flat. That flat was never purchased by them. While staying on the ground floor apartment of my parent's house the same actions of Sumit Sarkar continued. On a daily basis, he used to come home late at night in drunken condition and used to mentally and physically abuse me. His mother, Mithu Sarkar used to instigate him over phone. Apart from physically hitting me, he even used to hit me by throwing utensils, thus injuring me on many occasions.

He used to abuse and do many things against my willingness. During such continual period of abuse, I got pregnant with my younger son Suneet Sarkar. During my pregnancy, Mithu Sarkar used to hurl verbal abuse and derogatory comments on me. My younger son was born on seven (7) months pregnancy. Just before the delivery of my younger son, Sumit Sarkar's mother took him back to his own house on the pretext of some important work of personal nature and he was not present during delivery. The torture of various natures on me took its toll on my overall health and I went into depression for a long time.

My younger son Suneet is suffering physical ailments right after birth. I and my family kept quiet about all these activities, as it was a family matter and also to maintain my family's social prestige. My father's health deteriorated with time due to tension and anxiety. Then on 26th February 2019 my father passed away.


On the morning of 27th February 2019 at 2 am, Sumit Sarkar called me up on my phone through a lady friend of his and threatened and abused me. The mental condition of our family members on the day of the tragic loss was not in a proper frame of mind. When my family members called him up he gave the excuse that he was away from Siliguri at that point in time. His father and mother were called up and they came to our place. On being questioned about their son's whereabouts they submitted to the fact that their elder son Sumit Sarkar was having an affair with another girl for a period of four (4) years. The girl having affair with Sumit Sarkar posted pictures of their intimacy on the social media.

Sometime back, I was called on phone by a person (on the instruction of Sumit Sarkar) who threatened me and also told me that my son would be kidnapped if I do not return to his house and start to live with him. They even followed my elder son Supriyo to school. Just few days back, my son was lured by an unknown person at our house gate with gifts and chocolates while I and my mother was away from home temporarily for some work. I, my mother and my two sons are living at my own home under these disturbing circumstances. We are suffering from insecurity and live in constant fear for my family's security.

It is also to be noted that Sumit Sarkar in the recent past served jail sentence due to cyber crime and other IPC violations. These tortures are increasing on me from all spheres and seeing no way out I am compelled to report as such the misdeeds of Sumit Sarkar in the past and current situations.

I pray to your kind self to take necessary action against Sumit Sarkar and his family members at the earliest.
