Sir.

With due regard and humble submission 1 Smt. Anjali Malakar @ Anjali Sahani Wife of Sri Basant Malakar and daughter of Nilo Sahani, resident of Rajendra Nagar, Ward No I, P.O & P.S- Pradhan Nagar, Siliguri, Dist- Darjeeling do hereby submit—the following for your kind perusal and necessary action

1. That I was married to Sri Basant Malakar, Presently residing at Adhighat, P.O- Champasari. P.S Pradhan Nagar, Siliguri, Dist Darjeeling. 19 years Ago and out of the said marriage I have Four Children namely 1. Rupa Malakar married daughter, 2. Lal Babu Malakar minor Son, 3. Kusum Malakar – minor daughter and Palak Malakar minor daughter.

2. That after birth of my elder daughter my mother- in-laws started to torture me as a female child have been born to me and I tolerated as my mother in law will change her mind but all in vain.

3. That after the birth of a son the illegal act and activities of my mother-in—law did not change and she use to torture me regularly as my parents did not fulfill her demand of dowry.

4. That my in laws and my husband use to quarrel with me on each and every day and they use to beat me and I tolerated their illegal act and activities with a hop that they will change their attitude.

5. That after the birth of Kusum and Palak my mother in law and my husband use to torture me more painfully and behaved rudely with me and did not give sufficient food to eat and as my parents did not fulfill their demand.

6. That my mother in law drag me and my two minor daughter namely Kusum Malakar and Palak Malakar out of the house and I came to Coolipera, Rajendra Nagar, Ward No-1 at my relatives house to take shelter and my mother in law threatened me, if I return back than she would kill with the help of antisocial elements.

7. That I along with my two minor children started residing at Rajendra Nagar, Ward No-I, Siliguri and I use to pull the living of my said children by working as a daily Labor and after two year my husband came to me and started residing with me and he use Pull Hand Rikshaw and I use to work as a Daily Wages Labor and everything was good and normal.

8. That after elapse of few days my said husband started to consume alcohol and use to spend all money upon alcohol and when I demanded then he us to beat and quarrel me and also use to beat the minor children.

9. That when I raised objection against drinking alcohol/liquor then he left the house and went to his parents' house at Adhighat, Champasari and I and my said two minor child went to reside there at Adhighat then my husband and mother in law beat us mercilessly and did not let us to enter into the house and they threatened and told if I try to come again then they will kill by pouring petrol upon us.

10. That from sources I have come to know that my mother in law namely Smt. Hira Devi gave another marriage of my said husband Basant Malakar at Bihar and they have brought the said Girl/lady with them from Bihar and presently she is residing with them at their house situated at Adhaighat, Champassari, P.S- Pradhan Nagar, Siliguri and my mother in law and my said husban! have taken huge amount of dowry from her parents to marry her.

11. That after getting the information I along with my said children went to my husband / in law house to find out the facts and I saw the said lady sitting in the said house and my other two children who are residing with them told that their father have married another women and seeing me my riother in law assaulted me and she pulled my hairs and tried to strangulate my throat with the help of my husband and the said lady and all of them tried to kill me and I with the help of my children managed to escape from their clutch.

12. That My mother in law and my husband always torture me & my children physically and mentally and did not provide any amount for our livings and always create nuisance and drove us out of the house and threaten them if they come back then they will kill us by giving poison.

13. That mother in law and husband on each and every day use to beat me like a butcher and demanded money from me for their illegal act and activities and as I failed then they have brought another Girl from Bihar and married Basant Malakar.

14. That presently I am residing at Rajendra Nagar, Ward no-I, in a rented house with my two minor children and I am pulling their livings by begging and working as a daily labor as my husband is not taking any care of me and the two minor daughter and he is not paying any maintenance amount for our survival and I along with the minor children are passing the days in great pain, starvation and struggling for food tp live alive.

5 That my husband and mother in-laws are very greedy person and for money they can go to all extend and they have ruined my life for their ill motive and my mother in law have given another marriage of

my husband in an illegal manner for money and have ruined my life.

Under the above facts and circumstances you are requested to please take necessary legal action against the above named husband, mother in laws who have been continuously torturing me physically and mentally for their illegal demand of dowry and who also try to kill me & the minor daughters and have also married another girl of Bihar with Basant Malakar in an illegal manner in order to fulfill their illegal desire and ruined my life & the life of minor daughters, for their for which I shall be highly oblige.
