I, Suman Sengupta, Son of Ashoke Sengupta, A.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complain for breakage of Electric Poles & Damage of Property of WBSIEDCL near Nirjala Convent School, 3rd Mile, Sevoke Road, Ward 42, Siliguri, West Bengal 734008, P.S Bhaktinagar by vehicle no SK 07 D 0349, as found on site. Today Morning at around 8.30 hrs of 22.09.2022, a report was received by the undersigned regarding a vehicle damaging Electric Pole over telephone. The LT Mobile maintenance van of PHCCC was sent to site and the report was confirmed by the workers of the Maintenance van. Photographs Of the Incidents were taken and are attached here with. It was found that One Electric Pole along with other service infrastructure materials was damaged causing a Financial Loss Of WBSIEDCL of around Rs 17808/- (Rupee Seventeen Thousand Eight Hundred And Eight Only).

Thus you are requested to kindly initiate an investigation against the owner of the vehicle no SK 07 D 0349 under Section 139 of the Indian Electricity act 2003 amended on 2007.
