Thereafter on 21/9/22 we all came to my house and after searching at my house we found that the showcase has been fully opened and our all the gold-silver jewellery amounting to Rs. 4.50 to 5 lac has been steal away from our showcase.

It is pertinent to be mentioned here that one person namely Md. Abdul, s/o. Lt. Md. Sulaman of Ashrafnagar, P.S. Bhaktinagar, Dist. Jalpaiguri always asked me that he wants to see all the jewellery at once but I and my wife always refused his wish regarding our all stole jewellery.

I think said Md. Abdul and his associates Md. Amar, s/o. Lt. Md. Zahid and Md. Kalim, s/o. Lt. Md. Mustakin, all are resident of Ashrafnagar, Bhaktinagar. Taking the advantage of our absence, came to our house and broke our door lock and thereafter stole away all the Gold-silver Jewellery from our show case and the above noted three person worked at our building for 3 days, so it is my belief that the above noted person stole away our all Jewellery.
