Sir,

I, Suman Sengupta, Son of Ashoke Sengupta, D.E & SM Power House CCC, empowered by The Electricity Act 2003 amended on 2007 of India do here by lodge this complaint against Sri Sanjay Roy, Son Of Lt Bhola Roy, of Shanti Colony, South Ektiashal, P.S Bhaktinagar (PH- 9635008231). While on a routine inspection on 22.09.2022 at around 2.32pm, in the site having address City Plaza, Commercial Complex, basement floor, Siliguri, Darjeeling, West Bengal 734001, I along with Sanjay Prasad, O.E Power House CCC, WBSEDCL, found that the premises was occupied by Md Wasim Akram (7001524006, 8637844531), S/O Nasim and a shop by the name of Safe Motors was being operated by them. An Electric Meter was seen installed in the premises which was not being billed, and was not even in our system. On further investigation it was found that the property belonged to Sri Ankit Mittal, resident of Shanti Warehousing Corporation, P.O Salugara, P.S Bhaktinagar, Pin 734008, and was given in rent to Md Wasim Akram. Sri Ankit had handed over documents related to his property to Md Wasim Akram to obtain new electric connection in the property. An employee (Subhankar Saha) of Safe Motors owned by Md Wasim Akram had approached One By the name of Sanjay Roy, Son Of Lt Bhola Roy, of Shanti Colony, South Ektiashal, P.S Bhaktinagar who is not an employee or is related to WBSEDCL in any manner for the new connection. Sanjay Roy had told Sri Subhankar that he is a worker of WBSEDCL and took all the documents from him and installed a maliciously obtained energy meter and installed it at their premises, he had received an amount of Rs 2500/- from them. Accordingly the energy meter having serial no T1274790 (Single Phase), 5-30Amps Larsen & Toubro make, property of WBSEDCL was seized from the site, Labelled, and the seizure list was handed over to Suman Sarkar, Employee of Safe Motors. We exited the site at 2.50pm. A similar incident was reported against Sanjay Roy on 17.05.2019 in Bhaktinagar P.S via FIR No 362/19. Thus the accused is a repeat offender of similar type of crime. And many other maliciously obtained energy meter may be in possession of Sri Sanjay Roy.

Thus you are requested to kindly initiate an investigation against Sri. Sanjay Roy under Section 136 (1) (b) of the Indian Electricity act 2003 amended on 2007 of India and also under appropriate sections of the IPC.
