Sir,

In producing here with the accused person namely Subodh Das (38) S/O- Mahen Das of Halalpur, P.O- Runia P.S- Raiganj, Dist- Uttar Dinajpur, A/P- Baba Hotel, Sahidnagar More, W/No- 43, Ps .Bhaktinagar, Dist. Jalpaiguri under arrest along with following seized articles:-

- (1) 13 (Thirteen) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ML.

I, PSI Rantu Halḍar of Bhaktinagar PS, SPC do here by lodged a written complaint against above noted arrested accused person that on 23.09.2022 at 22.15 hrs vide GDE No- 1102 received a specific input from the source that the above noted person has kept huge numbers of illicit liquor in his Shop Baba Hotel in order to clandestinely dispose the same. Accordingly the fact is informed to I/C Bhaktinagar PS. As per his direction I along with Const-1431 Dilip Barman, CV/935 Biplab Roy left for Sahidnagar more, PS-Bhaktinagar, Dist-Jalpaiguri to verify the veracity of the information. On reaching there and as identified by source cordoned his hotel where he kept illegal illicit liquor. On arriving there found the above noted person who disclosed his identity as noted above and on search found huge numbers of liquor at his shop in conceals position. On being interrogation he could not produce any valid documents in respect of the said illicit liquor. He also stated that he is doing this liquor business since last 06 months for wrongful gain.

Accordingly I seized the same in presence of witness as per proper seizure list duly signed by the witnesses. The seizure was made in between 23.05 hrs to 23.25 hrs. On being asked he stated that he kept the same with a view to sale without any valid documents. As he has violated the norms of Bengal Excise Act as such I arrested him after observing all sorts' rules for selling the said liquor without valid license

Therefore I pray before your honour that a specific case may kindly be started against accused namely Subodh Das(38) S/O- Mahen Das of Halalpur, P.O- Runia P.S- Raiganj, Dist- Uttar Dinajpur, A/P- Baba Hotel, Sahidnagar More, W/No- 43, Ps .Bhaktinagar, Dist. Jalpaiguri as per proper section of law.
