I, Shahjadi Khatoon @ Sahzadi, W/o - Md. Zafray Alam, D/o – Md. Izhar Asrafi, Residing at Adarsha Nagar, Govt. Saw Mill Road, Ward No. 04, under the S.M.C., P.O. Siliguri Bazar and P.S. Siliguri, Dist – Darjeeling , PIN – 734005, in the state of West Bengal, would like to inform you that on 10th November 2016 I got married to Md. Zafray Alam, S/o – Md. Basir Ahamad, Resident of Karhatiya, Paschim Bari Tola, P S. Mabbi, Dist – Darbhanga, Bihar, according to the Islamic rights and customs. At the time of marriage my husband and in laws – (1). Md. Zafray Alam, S/o – Md. Basir Ahamad, (2). Md. Basir Ahamad, F/o – Md. Zafray Alam, (3). Firoza Khatoon, W/o – Md. Basir Ahamad, (4). Nargis Khatoon @Begum, W/o – Javed Ali, (5). Niyaz Banu, W/o – Md. Imran, (6). Rakiba Begum, W/o – Md. Mukim, demanded cash dowry that is 1,00,000/- (One Lakh) at the time of marriage including various articles and household items and other golden ornaments. My father agree to manage and pay them their demanded amount and other things demanded by them for my cordial marriage life. After few months of our marriage my in laws started pressurizing me with the help of my husband to bring more cash dowry from my paternal house and on refusal of their demand as my father is very poor they started torturing me both mentally and physically in order to extract money from my father. After marriage only I came to know that my husband is a habitual drunker and he used to pick up quarrel and use to abuse me with various filthy languages and beat me inhumanly, while complaining all this to my in laws they never give a heed to it and supported my husband. I was never treated as daughter in law in my matrimonial house but still I have tolerated all of their tortures in the hope that everything will get normal very soon. My In laws always provoked my husband to pressurize me for bringing money and one motorcycle but stating that my father is not that financially stable to fulfill their further illegal demand they again started beating me mercilessly. On 22<sup>nd</sup> August, 2017 out of our lawful wedock one Male child was born to us namely, Md. Ishrafil and later on in 6<sup>th</sup> July, 2021 one female child was born to us namely, Aliya Pervin, after I give birth to my second child who was female I was


always humiliated as to why did I give birth to a female child. Even afterwards I have been humiliated by them both mentally and physically and later on in 23rd July 2022 they have crossed all there limits, that day my husband and the above mentioned in laws started beating me mercilessly and threw me and my both minor children away out of my matrimonial house in presence of all the neighbors. That day being helpless I have come to my paternal house in Siliguri. After few days well wishers from both the family decided to sit for a meeting to settle out all the disputes mutually among us in a peaceful manner. My husband and all the above mentioned in laws came to my paternal house in Siliguri and started using filthy languages against me and my parents, that all of a sudden my husband and my in-laws became furious and beaten me and my parents by taking advantage of our innocence and fled away to Bihar.

In the above mentioned circumstances I request before your authority to please take proper and necessary legal actions against the above mentioned alleged persons with the strict provisions of Penal Law and your kind attention will be highly solicited.
