

Sir,

In producing herewith four (04) arrested accused persons namely (i) Badal Rangdar (28/M) S/O Ramvilas Rangder od Baggrakote, Sraban Nagar, Rana Busty, Ward No- 18, PS- Siliguri, Dist- Darjeeling. (ii) Manish Singh @ katia (19/M) S/O Bijay Singh of Mimika Road, khalpara, Ward No- 08, PS- Siliguri, Dist- Darjeeling. (iii) Bappi Sarkar (37/M) S/O Manoranjan Sarkar of Subhashpally Bazar, near Netaji Girls School, ward No.22, PS- Siliguri, Dist Darjeeling and (iv) Pankaj Basak @ Toton (30/M) S/O Sri Ram basak of Matingini- 1, Ward No 28, PS- Siliguri, Dist- Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz: .

1. One (01) iron made sword measuring 23 inch (approx) including wooden butt from the possession of Badal Rangdar which was kept concealed on his back side,
2. One (01) iron made Hasua measuring 17 inch (approx) from the possession of Manish Singh @ katia which was kept on his right hand,
3. One (01) iron made Sabol measuring 18 inch (approx) from the possession of Bappi Sarkar which was kept concealed on his back side,
4. One (01) iron made 'Knife' measuring 09 inch (approx) from the possession of Pankaj Basak @ Toton which was kept concealed on his left pocket.

I ASI Niranjan Sarkar of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Badal Rangdar, (ii) Manish Singh @ katia (iii) Bappi Sarkar, and (iv) Pankaj Basak @ Toton and others to the effect that today on 24.09.2022 at 01.30 hrs received a sources information that 12/13 persons have assembled at **Ganganagar River Ghat** under Siliguri PS with a view to commit dacoity at Khalpara area. The fact was diarized in GD vide Khalpara TOP GDE No- 574 dated 24.09.2022. Subsequently, after sharing the information with I/C Siliguri PS and O/C Khalpara TOP as per his direction, I along with ASI- Raju Sarkar, ASI Kala Chand Singha, ASI Uttam Kumar Dhar, C/1183 Nikhil Saha, C/490 Gopal Mahato, C/239 Badal Barman, C/516 Sunil Roy , CV/980 Ranjan Ojha left for the place to work out the information. At about 01.45 hrs after reaching Ganganagar Ghat, I met my source and being pointed by the source we started walking towards **Ganganagar River Ghat**. After reaching **Ganganagar River Ghat** started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from the spot seeing police personnel approaching towards them. They tried to flee away but on hot chase we managed to apprehend above noted four (04) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Khalpara area.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.55 hrs to 03.05 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

I accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at Khalpara area. It is also revealed from them that some others have assembled there with them and planned for committing the dacoity.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. **(i)** Badal Rangdar (28/M) S/O Ramvilas Rangder od Baggrakote, Sraban Nagar, Rana Busty, Ward No- 18, PS- Siliguri, Dist- Darjeeling. **(ii)** Manish Singh @ katia (19/M) S/O Bijay Singh of Mimika Road, khalpara, Ward No- 08, PS- Siliguri, Dist- Darjeeling. **(iii)** Bappi Sarkar (37/M) S/O Manoranjan Sarkar of Subhashpally Bazar, near Netaji Girls School, ward No.22, PS- Siliguri, Dist Darjeeling and **(iv)** Pankaj Basak @ Toton (30/M) S/O Sri Ram basak of Matingini- 1, Ward No 28, PS- Siliguri, Dist- Darjeeling and others and arrange for its investigation.
