Sir,

I, Smt. Gitashree Saha (Roy), Wife of Sri Indrajit Saha and Daughter of Haripada Roy, residing at Ashok Nagar, Ward No.31 of S.M.C., P.S. New Jalpaiguri, Dist. Jalpaiguri, like to bring to your notice the fact that I have been married according to Hindu rites and customs on 18.11.2020 with Sri Indrajit Saha, Son of Late Ranjit Kumar Saha and after the aforesaid marriage I started residing with my husband and in-laws in the aforesaid address.

That since after my marriage I came to know that my husband had a previous marriage which he did not disclose to me before entering into marriage tie with me. After the marriage my elder brother-in-law Sri Prasenjit Saha, sister-in-law (boudi) Smt. Dipa Saha and my husband started inflicting tremendous pressure upon me for bringing money from my mother so that he can start a business of his own. On several occasions my mother somehow provided money according to demand of my husband and in-laws thinking about my safety and secured future. But the greed of my husband and in-laws increased day by day and on several occasions they assaulted me mercilessly as my mother could not provide money according to their demand at the relevant time. I swallowed all such torture silently as my mother is a widow and she does not have the capacity to maintain me throughout the life. But my silence increase the anger of my husband and in-laws and they assaulted me and kicked me in such a way

when I was in advance stage of pregnancy for which my baby died in my womb and after that I had to undergo operation on 01.05.2022 for termination of my aforesaid pregnancy as per the advice of my Doctor.

That thereafter also the aforesaid culprits did not change their behaviour and still continuing their merciless physical torture upon me.

Last night i.e. in the night of 21.09.2022 my husband, his elder brother and his sister-in-law (boudi) assaulted me and turned me out of my matrimonial house threatening to set-fire on my body if I try to enter into my matrimonial home at any time in future.

In view of the above facts and circumstances I would request you to take immediate steps against my husband Indrajit Saha, elder brother-in-law Prasenjit Saha, sister-in-law (boudi) Dipa Saha as per law and oblige.
