**Subject: Complaint**

Dear Sir,

I the undersigned would like to inform you that I had married with one Rita Dey but my said wife died on 14.12.2019 and after her unfortunate demise I was mentally upset and, on the request of my family members I agreed to marry again and almost after the passage of one year of the demise of my first wife, I entered into a second marriage with one Puja Mandal D/O Pranballav Mandal, resident of Shantinagar Boubazar Near Roth Badal Sanga, District. Jalpaiguri, Pin 734006, on 24.07.2021 according to Hindu rites and customs at Sideshwari Kali Mandir and after the marriage I brought her in my residential address and we started to live together.

I would like to further inform you that on 27.04.2021, at night, when I requested her to consummate the marriage, suddenly she started to cry and I thought being a newly wedded wife, it must have been difficult for her to be intimate with me and I believed that a quality time is required to be spent with her and, on and from the date of the said marriage I further did not request her to perform sexual intercourse with me. After passing of more than thirty days, I found some massive change in her behavior and I also noticed that after the date of marriage, she did not have her menstrual cycle. It surprised me as I did not have consummated the marriage through sexual intercourse with my wife for one whole month from the date of marriage.

I would like to further inform you that finding no other alternative, I asked her about her menstrual cycle and date of periods. In reply she told me that she was about two months pregnant. After hearing the said information, I was shocked and I informed the same to her parents at the earliest.

But it was more surprising to me that when I came to know that my parents-in-laws were very much well acknowledged about the pregnancy of their daughter and they had intentionally arranged the marriage with me suppressing such shockingly vital information.

Thereafter, my parents-in-laws and my wife altogether started to beg for apology and they assured me that after the birth of the baby, which was there in the womb of my wife, she would start a conjugal life with me. Being a duty bound husband and a peace loving and obedient citizen of this country, I forgave my wife and her unnatural work and I



started to take care of her deliberately. I even took full responsibility of her day to day nourishment with proper treatment and regular checkups under proper guidance of a gynecologist.

I would further like to inform you that for livelihood, I work in a private firm as an electrical mechanic. Most of the time, I used to stay outside for my work purpose and I started to notice whenever I used to go outside for work related matters, the phone of my wife was continuously remained busy and whenever I asked her about the phone calls, she started to over react with me and she told me that if I could not believe her, she would leave my place with the baby in her womb and she further threatened me that she would lodge a false complaint against me and she would send me behind the bar if I again quarreled about the phone calls.

I would like to further inform you that during her advanced stage of pregnancy, she used to talk with a boy over the phone bearing number 76791-72737 for the whole night and I requested her not to remain sleepless and to take care of her health, as it would affect the baby inside her womb. However, she refused to listen to my advice every time and, suddenly she stated to me that the child inside her womb is not mine and the father of the said child is one of her boyfriends and it is needless to mention here that most of the time she spent her days in her paternal house. I would further like to inform you that suddenly during her 8<sup>th</sup> month of pregnancy, my wife told me that she has started to feel the labour pain and I took her to Roy Maternity Clinic, Siliguri. On 28.12.2021, my wife gave birth to a male child and being a duty bound husband I bore the whole medical expenses of my wife.

I would like to further inform you that after the birth of new born baby I brought her in my house along with the said new born baby and after spending some time, on a fateful night, the mother of my wife came to my house along with one male person who is unknown to me and claimed that said unknown person is the actual biological father of my said new born baby. And after elapse of two days i.e. on 11.02.2022, when I was in my job, my wife left my place with her said boyfriend and she started to reside in her paternal house.

I would like to further inform you that on 23.02.2022, I along with my old age mother Smt. Gita Rani Dey and my sister-in-law namely, Smt. Shyamali Roy went to the parents' house of my wife and requested her to come back to her matrimonial life but she refused to come back and moreover her parents and one of her sister, namely Priya Mandal attacked us, they used filthy language which cannot be uttered in a civilized society and due to their illegal act, I along with my mother and sister-in-law sustained greivous injury and finding no other alternative, I have lodged one written complaint to the officer-In-Charge, Ashighar Outpost under Bhaktinagar P.S. and on the basis of the said complaint, a case has been started against my father in law , mother in law and my sister in law being Bhaktinagar P.S. case no 230/22 U/S 341,323,325,354,354 B & 34 of I.P.C.



I would like to further inform you that I became very much surprise when I came to know that my wife brings so many false allegation against me and my family members and she lodged a case on 01.03.2022 before the O.C. Ashigharh under Bhaktinagar P.S. Case no. 250/2022, U/S 498 A , 307, 495,325,323,354 & 34 of IPC and we got bail from the Ld Court. Further, on a fateful night my mother in law called me and started demanding a Sum of Rs. 25 lakh and she also stated that if I would pay the said amount to her daughter then her daughter will gave me mutual divorce and if I refused I along with my family member would faces the consequences . It is very painful for me that my in laws after being aware of the facts and suppressing the Extra marital affairs of their daughter and they were aware that their daughter was pregnant before the marriage and they negotiated the marriage with me and they are trying to extort me and squeeze money out of me.

Under the above circumstances I would like to request you to investigate the matter & do needful for the ends of justice.
