Respected Sir,

I, Smt. Mina Goswami, Wife of Late Sushil Goswami, resident of Durga Nagar, Lelin Sarani, Ward No.40 of S.M.C., near Kali Temple, P.O.Sevok Road, P.S.Bhaktinagar, Dist. Jalpaiguri, would like to lodge this written complaint against my mother-in-law Smt. Bidya Devi Goswami, Wife of Sri.Rashbihari Goswami, resident of Durga Nagar, Lelin Sarani, Ward No.40 of S.M.C., near Kali Temple, P.O.Sevok Road, P.S.Bhaktinagar, Dist. Jalpaiguri, as follows:

That I got married to my husband namely Sushil Goswami (now deceased) in the 1995 as per Hindu rights and customs at parental house at Kranti Road, Odlabari and after my marriage my husband took me at my matrimonial house at Durga Nagar, Lelin Sarani, Ward No.40 of S.M.C., near Kali Temple, P.O.Sevok Road, P.S.Bhaktinagar, Dist. Jalpaiguri, where I started to reside with my husband and my in laws and we all resided together happily.

But unfortunately my husband died on 15/05/1997 in a road accident leaving behind me and my child in the womb.

That thereafter out of our marriage one male child was born namely Amar Goswami on 18/06/1997 who is now aged about 25 years.

It is very unfortunate to narrate that after the demise of my husband the entire scenario changed in my matrimonial house as my in-laws without any rhyme and reason started to create unwanted harassment to me causing immense mental pressure, distress and agony only with an intent that they will be successful to oust me from my matrimonial home with my minor child so that I would not have any claim over any property as widow of my husband.

That ~~all~~ though I kept mum and bear all abuse and torture only with a hope that time will heal the situation and everybody will accept me and so that I can have a peaceful life at my matrimonial home along with my son who needs and have a right over the love and affection of his grandparents which is very much important for the development and growth of a teenage boy who lost his father at a very early age.

That I am barely surviving my daily life but even then also I have managed to educate my son so that he can survive in this world. My in-laws never ever provided any assistance to me for my survival or even for the development and growth of my child.

That on 18/02/2022 my son got married and thereafter me my son and my daughter in law all are residing together in the same house of my in-laws having separate accommodation, fooding and other amenities.

That although we are surviving by ourselves without any help or assistance from my in-laws but still my in-laws used to quarrel with me on trifling issues and on flimsy grounds and used to torture me both physically and mentally and lastly on 31.01.2021 Sri.Rashbihari Goswami (father-in-law), Sri.Nirmal Goswami (brother-in-law), Sri.Pintu Goswami (brother-in-law) and Smt.Usha Goswami Wife of Nirmal Goswami they all mercilessly physically tortured me and tried to kill me and somehow I rescued myself from their clutch but I sustain injuries for which I compel to take legal action against them but no action was taken against them as they are very powerful and politically connected persons.

That finding no other alternative I had to file a petition under section 156(3) of Cr.P.C. before the Ld.Chief Judicial Magistrate at Jalpaiguri and as such lastly on 29/07/2022 a specific case being Bhaktinagar P.S.Case No.811 of 2022 under section 498A/325/506/354/307/34 of I.P.C.was registered by the Police against my in-laws namely Sri.Rashbihari Goswami (father-in-law), Sri.Nirmal Goswami (brother-in-law), Sri.Pintu Goswami (brother-in-law) and Smt.Usha Goswami Wife of Nirmal Goswami on the basis of my complain but they all get bail and now they became more furious.

That now my mother-in-law namely Smt. Bidya Devi Goswami along with the aforesaid in-laws are constantly harassing me by several means and also commits mental cruelty upon me whenever they gets an opportunity and forcing me to withdraw the said case and not only that with intent to oust me from my house my mother-in-law on 24/09/2022 cut my electric and water connection and they all physically assaulted me and continuously threatening me of dire consequences and also told that they will go at any extent to fulfill their wish not even hesitate to kill me and this time they will not fail.

Sir, I am in great fear and in great distress that my mother-in-law continuously threatening me that she will not spare me and will kill me to fulfill their wish.

You are therefore requested to take appropriate legal action against my mother-in-law for which I shall be highly obliges to you.
