**SUBJECT :- FIR against my wife Smt. Deepika Prasad for physical assault**

Respected Sir,

I, Praveen Gupta, S/o. Mr. Arun Kumar Gupta, presently residing at a rented accommodation in the house of SRI KRISHNA PRASAD, of Purbanchal (Pradhan Nagar), Behind Dhoop Company, P.O. & P.S. Pradhan Nagar, Siliguri, District Darjeeling, Pin-734003, in the State of West Bengal, INDIA would like to state that yesterday i.e. on 24.09.2022 at about 11:00 P.M. when I was returning home from my work place, I got stuck due to heavy rain & my wife namely Smt. Deepika Prasad, D/o. Sri Nandu Prasad, started quarrelling with me on issue of coming home late. She snatched my mobile phone. I tried to make her understand that due to heavy rain I was late but she ignored all my word and became ferocious. She physically assaulted me by sitting on my chest & due to her assault my full body is paining. Her anger is uncontrollable & when I tried to stop her she started shouting and kicked in my penis with bad intension. Being a man this is very shameful to get physically assaulted by his own wife but this is a fact that I am being physically assaulted by my wife often. I stay quite only to save my aged parents & other family members. This has become her regular habit. Earlier my wife had issues with my aged parents & other family members and to reside happily I left my home, my aged parents so that my wife resides with me happily but I failed to understand the needs of my wife. I am being residing with my wife at the rented accommodation since 9<sup>th</sup> September, 2022. I am facing mental problem due to the acts done by Smt. Deepika Prasad. She is a Advocate (tax consultant) and she threatened to lodge false FIR against me & my family members and put us behind bars. I left my rented accommodation and came before you for justice. Earlier also she lodged false FIR against me & all my family members at Bhaktinagar Police Station and we were enlarged in bail by the Ld. Court of Jalpaiguri.

It is requested before you in folded hand to kindly look into the matter and take necessary action against Smt. Deepika Prasad.
