I, Anuj Suri, am working as VP-Operations ay PP Enterprises,
4D, WEBEL IT PARK, Phase I, Paribahan Nagar, Matigara
734010.

Our office was closed on Friday, 09/09/2022 on the event of
demise of her majesty Queen Elizabeth II, the last queen of
England.

On Saturday, when we opened the office, we released that the
office mobile phone, which is generally kept on my desk, is
missing. I immediately contacted all office staff to find the
mobile and when we didn't find it anywhere, I asked my IT
executive to check the CCTV footage as when we closed the
office on Thursday, the phone was there.

When we saw the CCTV footage, we found that the mobile
was taken by one of our recent re-joined staff Riki
Mitra(Tubai) S/o Amit Mitra R/o Tumbajot, Matigara
(9733894099 / 6294874355), on Friday, which was an off day
for the office. We also were that he was searching my back
and after the footage when I check my back, I figured out that
even for the bag an amount of Rs. 60,000/- was missing,
which I kept in the bag for day-to-day incentives to the
distributed on the operations floor.

After watching the CCTV footage again and again, I also
found that on that day, he is wearing one of my t-shirts, so
therefore I came back to home to check my belongings to find
that he also stole my 8 t-shirts along with my neck chain made
of silver and may be other belonging which I am not aware of.

I would request you to please write an **FIR** against the Ricky
Mitra for Theft/Stealing and take necessary steps to recover
my belongings at the earliest.
