Sub-FIR for Hit and Run Case.

Respected Sir,

I, Ruma Rai, Age 48 Years, am writing this application to lodge a FIR for Hit and Run Case.

On Thursday evening of 15<sup>th</sup> September, 2022, I was crossing the main road in Kadamtala, Durga Mandir.

A two wheeler hit me and ran away, and I hit the pavement of the main road sustaining multiple injuries. The accident happened around 9pm in the evening and I was rushed into NBMCH Emergency Ward by a roadside shopkeeper in his vehicle.

I have sustained a severe head injury that required 8 stitches. My arm bone is broken (left) and requires surgery within the next 45 days. The doctor has recommended for the placement of a plate in my arm to fix the broken bone and a bone marrow injection. I wish to reclaim my Health Insurance which requires me to lodge this FIR. Kindly look into this issue.
