Salman, Son of Md. Paniya, 2) Md. Jagir, 3) Md. Basirul, both are sons of Md. Jaharu, all are residents of Panchkelguri, 4) Sri Paresh Saibo, son of Kartick Lal Saibo, resident of Mansara Jote, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling 5) Ranjan Munda, 6) Sangeeta Munda, both are residents of Madan Busty, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling, 7) Santa Kumar Oraon, Son of Bhadua Oraon, 8) Sakali Oraon, Wife of Santa Kumar Oraon, both are residents of Putinbari Tea Estate, Line No.- 6, P.O.- New Champta, P.S.- Matigara, Dist.- Darjeeling.

I am the recorded owner-in-possession of the land measuring 1.70 Acre, recorded in Khatian No.- 858, in Plot No.- 436, situated at Mouza-Khopalashi, within Police Station- Matigara, Dist.- Darjeeling and out of the aforesaid land measuring 1.70 Acre, I have started selling some portion of my land, during such sale, I have come to learn that the aforesaid persons, in collusion and in connivance with each other, have fraudulently procured, manufactured and forged some false documents and through which, the aforesaid persons have sold some portion of my aforesaid land with an intention to cheat me in deceitful manner and also with an ill intention to misappropriate the consideration amount of the aforesaid fraudulent sell.


