It is pertinent to mention here that my daughter was Facebook friend of the Above mentioned person and when my daughter stopped talking with him since 2 La. 2 months the Above mentioned person started threatening my minor daughter of dire consequences but today at around 2:30 pm Near Kamalpur Tea Estate he brutally assaulted my minor daughter with fist and blows

It is pertinent to mention here that the said person so brutally assaulted my daughter that while her treatment in Bagdogra Primary health check-up center she was referred to Bagdogra NBMCH and also Ad told by the doctor for the CT scan of the brain as the injury is very grievous in nature so finding no way out and thinking about the safety of my daughter I am lodging this complaint in your PS with a view that proper necessary action is taken against him.
