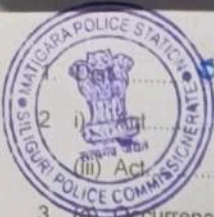

1. That I along with Surendra Prasad, S/o Sri Bipat Prasad, Sri Brij Kishore Prasad, S/o Late R.N. Sah, Smt. Suman Gupta, W/o Sri Ramesh Gupta, SMT. Gayatri Gupta, W/o Sri Reakesh Gupta, SMT. Sushma Gupta, W/o Sri Dinesh Gupta, Sri Prem Prakash Prasad, S/o Sri Goutam Prasad, S/o Late Ram Narayan, Sri Ashok Kumar Prasad, S/o Late Ram Narayan Sah, SRI SANTOSH KUMAR GUPTA, son of Late Sri Rajkishore Prasad, Sri Madan Prasad Gupta, son of Late Sri Rajkishore Prasad, Sri Anand Gupta, son of Late Sri Rajkishore Prasad, SMT MAMTA GUPTA, D/o Late Sri Rajkishore Prasad, Smt. Manju Devi, D/o Late Sri Rajkishore Prasad, Smt. Sima Prasad Gupta, D/o Late Sri Rajkishore Prasad, Smt. Laljhari Devi, Wife of Late Sri Rajkishore Prasad, All are resident of Sidhi Vatika, Burdwan Road, Ward no. 5 of S.M.C., P.O. & P.S. Siliguri, Dist. Darjeeling are the joint owners of the total Land measuring about 1.54 acre under the R.S. Khatian no. 6, L.R. Khatian nos. 3428, 3433, 3427, 3434, 3432, 3431, 3426, 3430, 3424 and 3429, R.S. Plot no. 204, 201, 201/262, L.R. plot no. 207 and 208, Mouza - Patiram, J.L. No.99 (New-77), P.S. Matigara, Dist. Darjeeling by the strength of five registered deeds of sale bearing no. 889 of 2003, 888 of 2003, 886 of 2003, 885 of 2003 and 887 of 2003. The land measuring about 1.54 acre has been recorded in our names under L.R. Khatian no. 3428, 3433, 3427, 3434, 3432, 3431, 3426, 3430, 3424 and 3429.
2. That very recently one Asha Kumari Singh, wife of Mithilesh Kumar Singh has trespassed into our land and unauthorizely constructed a tin shed house in some portion of the land. Asha Kumari Singh is most illegally residing in the said tin shed house. On enquiry we came to know that she

- has installed electricity by providing some false and fabricated documents claiming the land as vested. It is worthwhile to mention here that we are the absolute joint owners of the said land and our names have been recorded in the R.O.R. and moreover the land is not vested land.
3. That we raised objection and acquainted to her that the land belongs to us and she had no right to occupy the said land. We further asked her to quit and vacate the land but she refused to do so.
 4. That Asha Kumari Singh most illegally and unauthorizely without any valid document has erected the tin shed house and is residing there. She has manipulated and prepared forged documents.

Therefore we request you to take necessary steps against Asha Kumari Singh and thereby we shall be highly obliged to you.
