Sub: Intimation regarding damage of WBSEDCL property due to hitting by an unidentified vehicle on 26.09.2022 at around 05.00 AM at Netaji Pally (near Bharati Sevak Sangha) under the jurisdiction of Siliguri PS.

Dear Sir,

In reference to the subjected matter, this is to inform you that *an unidentified vehicle collided with WBSEDCL's LT network installed at Netaji Pally (near Bharati Sevak Sangha & behind the Samar Bidi factory) on 26.09.2022 at around 5.00AM, as gathered, under the jurisdiction of Siliguri PS & damaged WBSEDCL's property.* As the vehicle quickly escaped the accident spot after damaging our network, the detail information about the vehicle couldn't be traced. Thus the vehicle damaged the WBSEDCL property including one PCC 8M Poles, Wires & Conductors along with other fittings & service cables having approximate demurrage value of Rs. 25,000.00. Moreover, it resulted to 'No Power' situation at the nearby areas causing inconvenience to the public; however, we have already started necessary restoration work at the spot.
