I Neha Sha, w/o Bharat Sha, resident of Talbari  
Hat, P.O. - Talbari, P.S. - Pradhanagar, Dist. - Darjeeling would  
like to bring to your notice the fact that yesterday at  
around 10.30pm I received a phone call from my husband  
namely Sri Bharat Sha who is ~~an~~ a lawyer by profession  
and a member of Siliguri Bar Association that he was  
being severely beaten up by the staffs and the owner of  
Sharda Hotel, at Mallaguri, beside Mainale hotel, P.O. -  
Pradhanagar, Dist. - Darjeeling and asked me for help and  
come and save him and also stated that the staffs and the  
owner are making a desperate attempt to kill my husband.  
That after receiving the phone call without waiting any  
time I instantly went to the spot and after arriving there  
I found out that my husband Sri Bharat Sha is lying  
on the street near the Sharda Hotel and is severely  
injured and I instantly took him to the nearby  
Medica North Bengal Clinic, Pradhanagar for necessary  
treatment. That presently my husband is admitted  
in the ICU (Intensive Care Unit) at the Medica North  
Bengal Clinic and is fighting with life and death.  
Therefore, I hereby submit that the staffs and  
the owner of Sharda Hotel, Mallaguri, Beside Mainale  
Hotel, P.S. - Pradhanagar have made a desperate attempt  
to kill my husband for reasons ~~best~~ best known to  
them. So, I hereby request you to take necessary  
legal actions against the staff and owner of Sharda Hotel  
and oblige.
