- [ii] One transparent plastic pouch containing 10 grams of said to be Brown Sugar taken out as sample from Exhibit "A" for examination and marked as Exhibit "A-1"
- (iii) One Brown colour Honda Active Scooty having Registration No- WB74BE/3883 Marked as exhibit-"B" (Exhibit-A kept in Dickey of Exhibit-B)
- I, SI Deepak Kumar Singh of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused persons to the effect that on 26.09.2022 at about 18.25 hrs, I received a reliable source input that two male persons were coming from Darjeeling more side towards 2nd Mile Checkpost side with huge quantity of brown Sugar through a scooty for delivering the same to their designed customers at Siliguri area for their wrongful gain. The matter was diarized in Bhaktinagar PS vide Bhaktinagar PS GDE No. dated 26.09.2022 and subsequently, I informed the matter to the I/C Bhaktinagar PS,SPC and being directed, myself along with SI Sajal Roy, SI Srimanta Chatterjee, C/783 Santius Minj, C/828 Dulal Chandra Barman, CVF/619 Dharmendra Roy, CVF/614 Sumit Kumar Roy with investigation kit left for Sahidnagar More, NH-10 under PS- Bhaktinagar by govt. vehicle to verify the veracity of the information vide Bhaktinagar PS GDE no. 1218 dated 26.09.2022 and M.C.C No- 1354/2022 Dated

Under this circumstance any search warrant or authorization cannot be obtained 26.09.2022. without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter we reached at Sahidnagar More and meanwhile called two independent witnesses namely; (1) Saroj Singh -6oyrs s/o Lt Chunilal Singh of Prakashnagar PS Bhaktinagar Dist Jalpaiguri and (2) Anil Das-42yrs s/o Monoranjan Das of Pareshnagar, PS-Bhaktinagar Dist- Jalpaiguri and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure. Being accompanied by source and the witnesses our whole police party started

From the above noted facts and seizure of incriminating articles it is quite evident that the accused persons (1) Padip Prasad-28yrs s/o Lt Jugesh Prasad of Hemanta Basu colony, Ward No-4, PS Siliguri Dist Darjeeling and (2) Md Samshul-40yrs s/o Md Urfan of Hemanta Basu colony, Ward No-4, PS Siliguri Dist Darjeeling (not verified) are involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act. The whole process during search, seizure and arrest was video graphed by the videographer Sri Nitai Chowdhury of Shivarampally, Haiderpara PS Bhaktinagar Dist Jalpaiguri.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused persons namely (1) Padip Prasad-28yrs s/o Lt Jugesh Prasad of Hemanta Basu colony, Ward No-4, PS Siliguri Dist Darjeeling and (2) Md Samshul-40yrs s/o Md Urfan of Hemanta Basu colony, Ward No-4, PS Siliguri Dist Darjeeling (not verified) and arrange for its investigation.
