I, Sri Om Thapa, (Mobile No. 8974420652), aged about 34 years, son of Sri Tek Bahadur Thapa, resident at Block No. 3, Chungajan, P.O. & P.S. Chungajan, Dist. Golaghat, Assam, Pin 785601, presently residing at C/O. Sri Giri Prasad Thapa, Vill - Sainikpuri, Khaprail, T.C.P., P.O. New Chamta, P.S. Matigara, Dist. Darjeeling, Pin 734009 beg to submit that I am an Indian Army personal vide my Rank - Rfn/G.D.; No. - G/5012019 A, presently posted in Loding District, State - Arunachal Pradesh.

I have purchased a plot of land measuring 5 kathas or 8.25 decimal in Mouza - Nimai, under P.S. Matigara, Dist. Darjeeling, Plot No. 182 L.R., 155 R.S., L.R. Khatian No. 1546, 762 R.S., J. L. No. 57, Touzi No. 91, Dist. - Darjeeling, from its owner Sri Mahakal Gupta, son of Late Khedan Prasad Gupta, resident of C.R. Das Road, Chhota Ging, P.O. Lebong, P.S. & Dist.- Darjeeling, Pin 734105, vide a registered deed of sale being No. I-834 in the years 2019, registered at Bagdogra A.D.S.R Office on 14/02/2019.

After purchasing the said land I make cemented dhalai upto 3 feet on the four corner of my said land.

The aforesaid land has been in my physical possession since the date of my aforesaid purchase.

The aforesaid land measuring 5 kathas has been mutated in my name and a new khatian has been opened in my name in respect of said land vide new Khatian No. 1546 (L.R.) of Mouza - Nimai, J. L. 057 after recording my name in the R.O.R. maintain by B. L. & L. R.O., Matigara Block, situated at Shiv Mandir.

Above all Sl. No. a to f are the land mafia of the locality where my land is situated. They use to occupy the vacant land of the innocent owner and then either extort huge and handsome amount of money from such owner or sale such land after preparing fake land documents in the name of their associates.

On 26/09/2022 I came to Khaprail, Matigara where my relatives are residing and on 27/09/2022 at about 9 a. m. (morning ) I went to my said land to see the same and found that there is no cemented demarcation marking post in the four

corner of my said land which I fixed there on by cemented construction and there is demarcation of proposed Kacha Rasta run through the middle portion of my land which facilitates to go to the back side of other person's land. And seeing this I started to enquire personally as to made above. When I was asking to the nearby people regarding the aforesaid matter then the aforesaid 6 (six) persons namely 1) Sri Rinku Singh, 2) Sri Mahakal Gupta @ Munu, 3) Sri Ram Biswakarma, 4) Sri Hawldar Prosad Yadav, 5) Sri Manoranjan Roy, 6) Sri Sunny Thapa @ Munna came to me and demanded Rs. 20,00,000/- (Twenty Lakhs) only from me and threatened me by saying that until and unless I pay them the aforesaid amount of money, then they will not shift/remove the said demarcated proposed Rasta from my land and they will not allow me to enter my said land. They are also threatening me by saying that if I claim my said land without paying said amount of money to them then they will murder me and my wife if we came to my said land any time in future. Due to such threat I am in great fear of our lives and property.

The Xerox copy sale deed of my said land and its chain deed, khatian and Searching Report are enclosed herewith.

I therefore request you to kindly take necessary steps against the aforesaid persons so that they may not extort any amount of money from me and they may not grab my said land and also take necessary steps to punish them according to law.
